New ADA Title II Regulations for Websites and the Final Rule: What Does it Mean for Montgomery County Websites - Matt Barkley, ADA Compliance Manager, Montgomery County Government On April 8, 2024, Attorney General Merrick B. Garland signed a final rule under Title II of the Americans with Disabilities Act (ADA) to ensure the accessibility of web content and mobile applications (apps) for people with disabilities. This final rule clarifies the obligations of state and local governments to make their websites and mobile applications accessible.

Title II of the ADA requires that state and local government entities do not discriminate against people with disabilities in their programs, services and activities. The goal of the ADA Compliance Team is to coordinate Montgomery County government's overall ADA compliance efforts.

It was asked how the libraries will be affected by this ruling as they offer many resources via third party vendors such as the Washington Post or high school graduation tests. Matt said if the vendor is providing services through a paid contract then they would have to comply.

The floor was opened to questions and comments.

Betsy Luecking, Staff, noted that the majority of County employees do not have a license for Adobe Acrobat Pro. It will be a challenge to train employees on how to post documents that are accessible. She will continue to work on this issue.

Commissioners commended Myra for her knowledge and expertise and her ability to explain how to make documents accessible in a way that is easy to understand.

Felicia Brannon, Commissioner, asked Myra to assist her with ensuring the transportation newsletters she shares with members of the Leisure World community are accessible.

It was noted that while fixing websites at the page level to ensure they are compliant will be important, the biggest hurdle the County will face will be ensuring documents are accessible. It was recommended that the County hire an accessibility company to consult with and to provide the level of accessibility needed to meet the new requirements.

Chair Update

The Commission will not be having a Steering Committee meeting this month as June 19 is a federal holiday and the County will be closed.

It was discussed that a retreat should be held at the September meeting to discuss goals and budget priorities for the upcoming year. The meeting may possibly be held in person.
