- <u>SB0768</u> Criminal Law Victims of Child Sex Trafficking Safe Harbor and Service Response- Nothing has been written by the Commission on this bill
  - a bill to provide a safe harbor/immunity from prosecution for minor victims of sex trafficking. The hearing on the cross file is this week (HB 833, sponsored by Del. Lierman, on 2/17), but we have time to submit testimony in the Senate. That hearing is on March 8. Under the bill victims will no longer be able to be detained in a juvenile facility or adjudicated as delinquent for prostitution or other offenses committed as a result of sex trafficking.
