Commissioner Updates/Announcements

- **Jennifer Arnaiz** provided updates on ECEI projects:
 - Shared Services and Facilities Fund studies have concluded and will be preparing to release as an RFP shortly
 - Cost of Quality Care and Supply and Demand studies are in progress and hope to be completed by fall
- **Tara Phillips** re. MSDE Market Rate Study survey participation has been extended until April 29th; this study will collect date on the cost of care in the State of Maryland; currently only 1000 providers (out of 7000) have completed the survey; providers are concerned about sharing information; MSDE is working to recruit Spanish speaking providers to participate
- **Laurie Moran** announced Office of Child Care hosted a roundtable where providers were invited to ask question about CCSS, EXCELS, etc.
