Meeting Minutes Agenda Items

- 1. Guest speaker presentation on sexual and reproductive health, adolescent mental health, community-led interventions, and working with marginalized youth and families
 - a. Presented a contemporary understanding of resilience as a dynamic, contextual process rather than a fixed trait.
 - b. Emphasized the importance of supporting system-level change in addition to individual support.
 - c. Noted that trauma and chronic adversity reshape developing brains, affecting behavior and learning in youth.
 - d. Highlighted that one of the strongest protective factors is a consistent, nurturing relationship with at least one adult caregiver.

2. Other Business & Discussion

- a. The Commission discussed a draft 2025-2026 Priority Statement. The draft text will be reviewed once more by the Chair and DHHS Liaison before being shared with the County Executive's office.
- b. Additional members introduced themselves.
- c. The Commission discussed the need to review possible guest speakers for upcoming sessions.
- d. There was a discussion about reviving the Dworkin Awards, which previously ran for 33 years before being paused in 2020 because of the COVID-19 pandemic.
