#### **ECE Collaboration Updates:**

- o County Executive's proposal for the ECCC Barbara Andrews and JoAnn Barnes
  - Restructure County ECE Initiative Steering Committee and ECCC to be new Early Care and Education Coordinating Board (ECCB)
  - Early Care and Education Initiative (ECEI) met with County Council members. Outcomes:
    - MMF will conduct the Coordinating Entity Study due by December 31,2020.
    - **ECCC** role:
      - 1. Remains the Local Early Childhood Advisory Committee (ECAC) within MSDE ECAC system
      - 2. Remains the coordinating entity for early childhood
      - 3. Remains in an advisory role to the County Executive, County Council and MCPS
    - > JoAnn Barnes will work with MMF on the entity proposal
  - Throughout the fall and until the time the MMF Entity study is released, the ECCC will continue its scheduled work:
    - Work on the ECAC Quality Enhancement Grant
    - Strategic Plan priorities
    - Community outreach to parents and providers
    - Collaborate with MMF and the ECEI Steering Committee

**Update from Montgomery Moving Forward (MMF) re: Coordinating Entity Study and Council Funding –** Sharon Friedman, Susan Madden and Maria Navarro

- Early Care and Education Call to Action for Montgomery County The workforce of today are those working in the
   ECE field and the needs of working parents, and the workforce of tomorrow, which is focused on the school readiness and success of children entering kindergarten.
- o Proposal for report and recommendations for an independent public/private ECE partnership: funding was approved unanimously on September 15, 2020 with \$75K from Montgomery County, along with \$25K generated from donations from businesses foundations in Montgomery County. MMF will prepare a blueprint for an efficient, effective, equitable system of high-quality ECE to meet the needs of children, families and employers throughout the community. Provider and parent voices will be essential to the final recommendations made. Report and recommendations will be due by December 31, 2020.
- Three partner organizations/initiatives recommended to County Council included the ECCC, the Children's
  Opportunity Fund and the Collaboration Council for Children Youth and Families. MMF will provide a set of
  recommendations and give guidance as to how the entity might be stood up. The goal is to be a neutral, cross-sector
  convener of planning to stand up the coordinating entity.

- Letter of support is being requested from ECCC to include in grant application

# Update on Child Care Reopening – Jennifer Arnaiz

- MSDE allowed reopening in July
- As of Monday, September 14, 2020, 75% of Child Care Centers and 80% of Family Child Care had reopened, although
  not all programs were at previous capacity; 650 programs replied to R&R survey, results show that 98% of Child Care
  Centers and 90% of Family Child Care (number of household members counts toward capacity maximums: no more
  than 15 total) are operating at an average of 50% of allowable COVID capacity.
- School-aged programs new need during school hours so young children have supervision and older children have academic and technical support while parents are engaged in their work or out of home at work; MCPS has allowed DHHS CCIPS sites to reopen for young children and CUPF space to be identified for school-aged children; these operations meet all the MDH and MSDE public health precautions. The County is prioritizing care for children of teachers, essential workers, and from low-income families. The Community Foundation has done fundraising for child care scholarships at targeted school communities. MSDE is not allowing child care waivers for other types of group care such as recreation, libraries, learning pods, etc.
- o A reference guide and posters will be available in October

## Infants and Toddlers, ChildFind and MCPS Special Ed. Services – Mary Manning-Falzarano and Amy Cropp

- Program design during remote MCPS instruction
- Family engagement additional supports for parents to continue activities within the family throughout the week so
  not solely relying on weekly therapist appointment; Family Support Network Coordinator focused on engagement to
  send information and resources to families twice a week at the beginning of the isolation period; continued outreach
  to families at least monthly for the families who withdrew from weekly/regular visits
- At-home supports MCITP paused services for 2 weeks in March, began to research virtual service options; resumed
  when MCPS restarted classes; continue billing through Medicaid and using HIPAA compliant platform as well as
  expanded Zoom features; most families opting for shorter than 45min visits due to engagement difficulties with
  young children through virtual settings; county provided Chromebooks and hotspots for families who requested
  them; facilitating virtual playdates twice a week, including break-out rooms, to conduct group activities (providers
  and families have both enjoyed these activities)
- o MCITP referrals are down, but have started to increase in September, same trend across the state
- o MCITP part of DHHS telemedicine planning group; face-to-face planning, but will not resume until MCPS begins
- Families in Maryland can keep their children in Infant and Toddler Program until age 5 if preferred, at this time more families are choosing to stay and not transition to MCPS at age 3
