Update on Early Childhood Independent Coordinating Entity:

(Dr. Barbara Andrews and Vivian Yao) February 15, 2022, County Council unanimously approved Bill 42-21; will require the Council to designate a nonprofit corporation to serve as the County's Early Care and Education Coordinating Entity as well as establish its guidelines and duties; Council has not confirmed the nonprofit that will serve in this capacity; part of the initial work of this entity is to examine what ECE advisory groups already exist in the County and determine their future role/purpose; ECCC will continue to focus on their work as planned until decisions are made about the future role of advisory groups

Update on *The Basics* **Program:**

(Jade-Ann Rennie, Collaboration Council) Collaboration Council continues their work on the Basics program; met with implementation partners to find out the strengths and needs; working to identify parts of the program that need to be tweaked to improve future implementation; working to train staff on the Basics; planning larger community events once weather warms

(Dr. Barbara Andrews) Maryland General Assembly is currently in session; there are a number of bills focused on child care sustainability; joint bill package will focus on revolving loans for providers, workforce initiatives and improvements to the State Child Care Scholarship Program; House Bill 513 will focus on greater funding for the Infant and Early Childhood Mental Health Consultation Program

(Jennifer Arnaiz) ECS, Child Care Support Services will be hosting a series of forums in the coming months for both providers and parents; information gathered from these forums will be used to identify gaps; forums focused on parents/caregivers will be offered in both Spanish and English
