- Cassandra Malik shared information on a MCPL pilot program called "Hatchlings" which is an interactive early literacy program for expectant parents; also teaches about brain/body development; Part 2 of the pilot will be offered in October 2023 for infants up to 4 months and their parents/caregivers.
- Richard Crump announced that next month Quality Time ELC will be breaking ground on a new site that will allow them to provide 220 additional children.
