- Discuss ways to keep work of ECCC structured without any formal leadership
- Brainstorm priorities or work plans for 2023-24 ECCC year

After a brief discussion and poll, the majority of the ECCC members opted to postpone the annual planning retreat until the fall and host a ECCC meeting on June 21, 2023.

Community Announcements and Updates

- Jennifer Arnaiz shared that ECS/CCSS recently hosted a Director's Retreat focused on empathetic leadership; over 40 ECE directors were in attendance
- Mary Manning-Falzarano (ECS/ITP) shared that ITP has recently hired a contractor to manage the early screening

and medical outreach initiative; currently working to create outreach materials; also working to purchase <u>CHADIS</u> to help facilitate communication between the child's pediatricians and early interventionists

- Laurie Moran (MSDE/OCC) shared that almost all of the licensing specialists vacancies have been filled; Laurie also shared information on the "emergency suspensions" procedure of child care programs and the collaboration with Child Welfare Services; OCC is taking a closer look at the policies/procedures around this process; Jennifer A. recommended that Laurie host a "chat" with child care providers and parents so they can be updated on the emergency suspension procedure
- Laura Jahromi (COA) stated that the open grants round provided by the Children's Opportunity Alliance will be closing in one week
