Update: Head Start Community Base Support (Charlene Muhammad)

Charlene Muhammad provided an updated on the pilot program that is targeted to help those 3-year-olds aging out of Early Head Start locate a seat in a participating community child care program. Last spring 6 community providers applied to participate in the pilot. Program is currently working with two community-based programs (CentroNia and FSI).
