Help your neighbors in need during the holiday season!

THE CHALLENGE

Imagine that the holidays are approaching and your family is stuggling to make ends meet. You don't know how you are going to pay the rent, much less manage to make a formal Thanksgiving dinner or afford gifts for your children during the December holidays.

This is the reality for many families living in Montgomery County: a typical family of four needs over \$91,000 in income to afford the basic necessities in the County. Children in the County experience a poverty rate of over 9%, while 35% of public school students qualify for free/reduce meals (FARMS).

THE SOLUTION

For over 30 years, the Holiday Giving Project of Montgomery County, Maryland, has provided Thanksgiving and December holiday assistance to low-income households.

A network of social workers, school counselors, and other human service professionals refer families in need for holiday assistance to the County's Department of Health and Human Services. The Department then distributes validated referrals among the Holiday Giving Coalition formed by local non-profits, faith-based organizations, and governments. Each member of the coalition adopts specific zip codes in the County to serve referred families in need, including by providing food, gift cards, and toys collected through donations.

In 2018, the project successfully matched 10,328 families (incl. 21,117 children) for Thanksgiving and 10,962 families (incl. 23,095 children) for December with 31 Coalition members. MCPS provided half of all referrals.

WE NEED YOUR HELP: AREAS OF NEED

In a community as fortunate as Montgomery County, no child should miss out on the joys of the holidays. But while the Coalition comes closer each year to assigning all referred families in need, some zip codes still struggle to meet demand. In 2018, 686 families with a combined 1,233 children went without a match for the December holidays. Particularly highneed zipcodes include:

 Aspen Hill and Wheaton: 20906 and 20902 (estimate: 900 families)


Silver Spring: 20903and/or 20910(estimate: 500 families)

Bethesda-CC: 20814,
 20815, and 20817
 (estimate: 100 families)

 Burtonsville: 20866 (estimate: 80 families)

HOW CAN YOU HELP?

Become a part of the solution – become a Coalition member as a "Zip Code Coordinator" (ZCC) and adopt all or part of a high need zip code! Coalition members solicit donations, organize assistance distribution events, and communicate the details of the events to recipients and referring parties. Referrals made to the Holiday Giving Project are assigned on a first come basis, as capacity allows.

HOW TO SERVE

Step 1. Deciding on your role as a "Zip Code Coordinator." Work with the Holiday Giving Project coordinators to determine:

- ☐ Which holidays you will serve (Thx/Dec).
- ☐ How many residents you plan to serve.
- ☐ What zip code(s) you would like to serve.

Step 2. Kickoff the season.

- ☐ Assemble your team.
- □ Define internal roles.
- □ Obtain Holiday Giving database training.

Step 3. Solicit donations from community members, area businesses, and others.

- □ For Thanksgiving, consider obtaining food through internal donations, partners like Manna, or private sponsorships. Note that ZCCs typically provide \$10 grocery store gift cards in place of a frozen protein.
- □ For December toys, consider internal donations, sponsorships, or partnering with Toys for Tots. Note that you will need your own transportation for Toys for Tots pickups. Many ZCCs provide gift cards rather than toys for children over the age of 12. Some also provide food.

Step 4. Receive referrals and participate in the Holiday Giving Coalition.

- □ Track your assigned referrals via the webbased Holiday Giving database.
- Participate in monthly meetings (Aug-Jan).
- Coordinate with Coalition members and the Holiday Giving coordinators.

Step 5. Plan your distribution events.


- Determine mode of distribution: delivery, pick up by client, or work with referring org.
- Determine time of distribution—one or multiple events/locations?
- □ Notify referred families via phone, text, email, post cards, and/or mailed letter.
- Verify participants (sign in sheet, ID check) secure and confidential.
- ☐ Share any leftover items with Coalition members for distribution to families.
