Overview

- HUD will be awarding approximately \$322,000,000 million as part of the 2022 Supplemental Unsheltered CoC Competition.
 - Funded with reclaimed funds from previous CoC NOFO competitions.
- Montgomery County is eligible to apply for up to \$4,870,352.
 - Up to 3 percent of this amount can be used towards planning funds.
 - Grants is for 3 years
 - \$1,623,450.67/year
- Focus on those unsheltered, at-high risk of unsheltered homelessness, and/or severe needs
- No Tiers – all projects will be reviewed, rated and ranked

HUD Policy Priorities

- Reducing Unsheltered Homelessness
 - Focus with those with severe service needs
 - Identifying anyone living unsheltered and connect directly to health and housing resources.
 - Enhance HMIS to collect more comprehensive data
- Involve a Broad Array of Stakeholders
 - Demonstrate coordination with a variety of stakeholders to develop and implement plan to serve unsheltered
- Advancing Equity
 - Focus on system and program changes to identify and address the needs of those disproportionately more likely to experience homelessness
- Housing First
 - Correct implementation of Housing First
 - Note HUD's use of the word correct – not just policy but proper implementation

Eligible Projects

- Permanent Housing
 - Permanent Supportive Housing
 - Rapid Rehousing
- Joint TH and PH-RRH
- Supportive Services Only
 - Coordinated Entry
 - Street Outreach
 - Standalone Supportive Services
- HMIS
- CoC Planning

Hard Costs (acquisition, constructions and rehabilitation) are **NOT** eligible.

CoC Ranking and Review Process

All projects will be reviewed & ranked by the CoC Unsheltered NOFO Allocation Committee per the established CoC process.

Projects will be assessed using a standard scoring tool.

The Allocation Committee will prioritize projects based on CoC needs and project scores to maximize the opportunity for funding.

Project Scoring Criteria

CoC Score

- Project Capacity
 - Coordinated, inclusive and outcome-oriented process for developing the application
- System Performance
 - CoC wide metrics on reducing homelessness
- Coordination and Engagement – coordination with other systems of care
- Plan for Serving those with sever service needs
 - Leveraging of housing and healthcare, landlord recruitment
 - Shelter identification for those currently unsheltered
 - Prioritization
 - Involvement of those with lived experience
 - Plans to serve the underserved and enhancement of equitable housing interventions

Project Ranking

Serving Structurally Disadvantaged Areas

- Commitment to serving households in geographic areas with high levels of homelessness, housing distress and/or poverty

HUD Scoring Criteria

- CoC Consolidated Application funded by highest ranked.
- Top CoC projects are funded first and then HUD will move on to next CoC.
- No more than 10 CoC will be funded in each State.

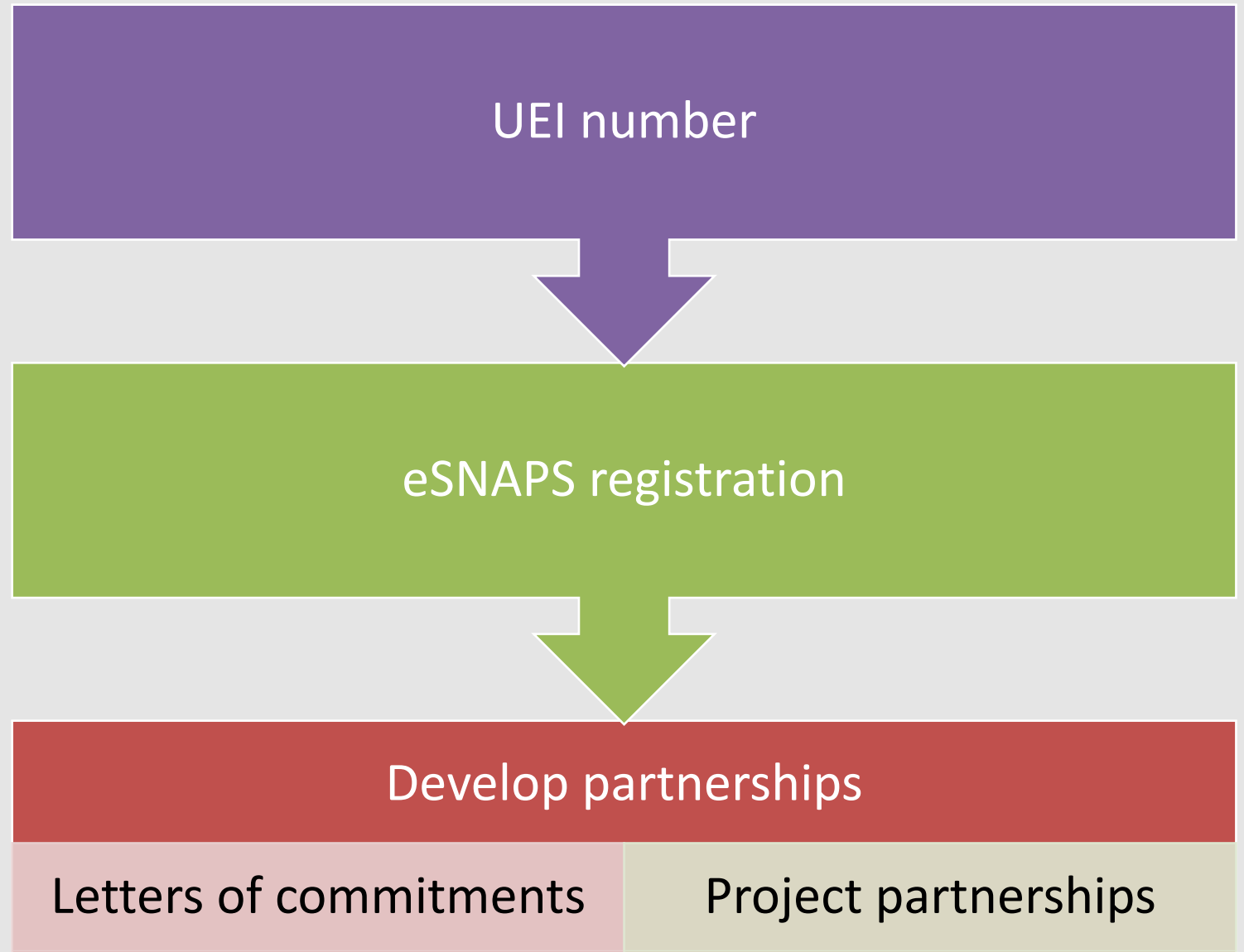
This is a very competitive process. Partnerships will be critical to our CoC receiving funds.



Match and Leverage

- **Leverage** – Projects are expected to leverage funds from partners including healthcare, mental health providers, and landlords.
- **Match** - All projects must meet match requirements to be eligible.
 - HUD requires a minimum of 25% match on all grant funds except for leasing costs.
 - Match can be **in-kind** or **cash**.
 - DHHS **MAY** provide current match funding for renewals and provide **15% cash** match toward new projects.
 - Any cash or in-kind funds used towards match must be used to support eligible activities under the grant.
- Rents and occupancy charges collected from participants is considered program income and can be used as match.

Important Deadlines

- **August 22, 2022** – Letters of Intent to Apply Due
- **September 12, 2022 - by 5 pm All Project Applications DUE**
 - Completed application include NEED TO REVISE - 1) CoC Project application; 2) Projects full budget (**total cost** to operate project) 3) Letters of Commitment 4) Required Addendums.
 - Submit to Ilana Branda in PDF and excel format via email at Ilana.Branda@montgomerycountymd.gov and cc' Elizabeth.Driggers@montgomerycountymd.gov
 - Do **NOT** submit CoC Project Application via e-SNAPS until you are notified
- **October 5, 2022** - No later than Oct 5th Notification of Project Selection and Priority Ranking will be provided to agency and posted to website
- **October 18, 2022** – All ranked applications should be submitted via eSNAPs
