**Old Business:** The minutes from the May 7, 2024, meeting was approved.

#### 1. New Applications:

- Bay State Custom Homes L.L.C.: Approved. They missed the renewal deadline; they are considered a new registration. Board questioned court cases, applicant explained that they hired and then had to fire an electrician who they claim underperformed and acting unprofessional. They also have a judgment against the electrician. Board also questioned applicant about a potential contract, applicant is waiting on a survey to be provided and that it will then be under Bay State Custom Homes L.L.C.
- Craftsman Group LLC: Conditionally Approved -will need a pre and post dry wall inspection for 2 jobs. Board questioned if applicant was affiliated or related to JRK Contractor LLC, applicant stated their brother was involved but he has no ties and has removed them from their lives. Board also questioned building experience; resume will need to be provided as part of conditional approval.
- JL City Concrete Incorporated: Conditionally Approved -will need a pre and post dry wall inspection for 2 jobs. Board questioned experience and if they are only familiar with concrete work. Applicant replied they have only ever performed concrete work but is familiar with the construction industry. Board also questioned if they were involved in the wrongful death incident with Village Concrete. Applicant stated they did work with them in the past but are now a separate entity.
- Procraft Construction, LLC: Approved. Applicant was previously registered as a new home builder. Applicant claims to be building a new home where the permit is currently under a registered new home builder, Legend Builders. Board advised that prior to signing a contract or performing work they would need to be registered and assume the permit. Board questioned why they missed the renewal period. Applicant stated it was due to covid and their ex-business partner missing the deadline to submit application. Board also questioned ties to Legend Builders.
