Role of CABs

- Provide residents with an opportunity to express their views and priorities for future capital improvement projects.
- Provide information to the County Executive and Departments concerning capital improvement projects.
- Information is included in the Public Input Section of the County Executive's Recommended CIP budget book.



Capital Improvements Program (CIP)

- Capital Improvements have long-term usefulness and require large expenditures of capital funds usually programmed over more than one year and result in a durable capital asset.
- Biennial CIP Process.
 - Full CIP submitted in even numbered years
 - Amendments submitted in odd numbered years
- Six-year plan.
- Includes capital expenditure estimates, funding requirements, capital budget requests and program data.



CIP Schedule

- September: MCG Departments Submit CIP to OMB
- September: Council Approves CIP Spending Affordability Guidelines (SAG)
- September December: OMB Reviews
- January 15th: County Executive Transmits to the Council
- February: County Council Public Hearings
- February: County Council revisits Spending Affordability Guidelines (SAG)
- February May: County Council Committee Reviews
- May: Full Council Reviews
- Before Memorial Day: Council Approval



CIP Schedule

Agency Submissions to Executive and Council

- Oct. 1: WSSC to Executive and Council (no biennial CIP)
- Nov. 1: Superintendent to Board of Education
- Nov. 1: M-NCPPC to Executive and Council
- Mid Nov.: College to Executive and Council
- Dec. 1: BOE to Executive and Council

Council Role

- Review the Executive's Recommended CIP with OMB, Departments, and Agencies
- Conduct Public Hearing
- Committee and Full Council work sessions
- Approve FY15-20 Capital Improvements Program and FY15 Capital Budget




Recent CIP Funding Summary

FY13-18 Approved CIP (as amended): \$4.389 Bn.






CIP FY13-18 GO Bonds

FY15-20 Fiscal Outlook

Operating Budget & Capital Budget

- Three ways the budgets intersect
 - Cash payments for capital projects
 - Operating costs for new facilities
 - Debt service

Every \$1 million used for debt service could also be used for:

13 public school teachers 9 police officers 9 fire fighters **Operating 1 library Operating 5 recreation centers** Rental assistance for 427 families 31,250 bednights in family shelters 11,111 bednights at overflow motels Respite care for 339 clients Child care subsidies for 197 children for a year **Services for 4,124 Montgomery Cares clients** 1,274 county-funded Maternity Partnership program 1,919 Housing Stabilization grants Pruning 2,150 trees **Purchasing 2 buses** Renovations for 50 bus stops



FY15-20 Strategy

- Continue the work of restructuring the CIP:
 - Align with forecasted revenues
 - Control rising debt service costs
 - Ensure sustainable operating budget impacts
- Requests for new projects should be directly responsive to either critical or high priority objectives.
- Consideration will be given to reducing, eliminating, or delaying non-critical projects.
