Please take notice that the Office of Zoning and Administrative Hearings for Montgomery County, Maryland, will hold a public hearing on **Tuesday, July 9, 2024 at 9:30 a.m.** or as soon thereafter as this matter can be heard, on the above-captioned request for a waiver of the on-site parking requirements for an accessory dwelling unit on property located at 7012 Braeburn Pl, Bethesda, MD (DHCA Application No. 153298).

This hearing will be held remotely via Microsoft Teams You do not need to sign up in advance to testify or view the hearing. You do not need a subscription to Microsoft Teams to join the hearing. Instructions to access the public hearing may be found under the link “Public Hearing Remote Access and Exhibits” and the Hearing Calendar on OZAH’s website at least two days before the public hearing. **Exhibits not submitted at least two days before the hearing may not be posted on the website.**

All exhibits filed in the case will be available to view via the link “Public Hearing and Remote Access at least one day before the public hearing. The exhibits are removed immediately after the public hearing. If you wish to download any of the exhibits, you should do so by 5:00 p.m. the day of the public hearing.

The entire file may be reviewed in the Office of Zoning and Administrative Hearings by appointment, Monday through Friday, between the hours of 9:00 a.m. and 4:00 p.m., prior to the date of the hearing. If you wish to review the file in person, please contact Ms. Nana Johnson at (240) 777-6663.

In addition to all other requirements, any party submitting documentary evidence for the record must file electronic copies of their submissions. Amended electronic copies must also be submitted of any amended documents. Electronic copies must be submitted on external storage media, including Compact Discs or DVDs, in Microsoft WORD format for text documents, and in PDF format for plans, photos and other non-text documents.
