

## CLOSING REMARKS

DECEMBER 4, 2024 BY 12:00 PM

1. I beg the court to continue this license application for one year from the date I received the complaint on November 18, 2024. I will take a picture of something that ONLY happened on the day I take the picture and present that for evidence when the year is up. I already submitted November 18<sup>th</sup> picture of the Montgomery County Leaf pickup, and yesterday, December 3, 2024 my trailer with most of the bulk trash pick up for Thursday December 5<sup>th</sup> of the fence that for my inspection I was either replace, repair or remove
2. Yes, I have not been able to pull up the arguments against the building of my adu, but yes, Caleb and Felipe Moskaitis were adopted from Montgomery County Social Services, and Caleb when he was adopted chose his name – caleb who helped Joshua in the battle of Jericho (my oldest son is Joshua) and for his middle name he chose, John after John Hawkins his social worker – who I believe still works at Montgomery County Social Services. His adopted dad Vince Moskaitis, the last 45 days we lived at our home at 25129 woodfield school rd in Gaithersburg called the police 25 times to get them removed. Yes, Caleb and Felipe were both adopted with crack and alcohol in utero, were adopted by Vince Moskaitis who did not want them when they became teenagers (he actually wanted none of them, and quit his job in October of 2001, stopped paying court mandated child support of \$200 when Felipe turned 18, which was against the court ordered settlement agreement till all children had a hs diploma. Caleb has co-occurring disorders of both substance abuse and mental health. He came to us with a psychological record of over eight pages, and I am vigilant in his healing. Maybe now that he is locked up in Clarksburg, John Hawkins can provide some county services to him. Felipe Moskaitis was a very angry young man in his teens – as I am sure the court reports show (I am currently volunteering as a school librarian and do not have access once again to a printer till my lunch break, when I will add the exhibits, however for the past eight plus years he has worked a steady job at Home Depot, Bethesda, has had no police record and takes wonderful care of his son. However I fail to see how my children’s actions have ANY bearing on my building an adu to take care of myself in my golden (?) years with a diagnosis of severe osteocronosis, etc (previously submitted.)
