If you have not already done so, are you able to send us a draft Declaration of Covenants for inclusion in the record ahead of the hearing on November 21<sup>st</sup>?

The Technical Staff Report (Exhibit 29 at page 4) recommended the following binding elements:

- 1. The use of the property will be limited to self-storage.
- 2. Vehicular access to the site will be limited to a single, consolidated access point.
- 3. Any building on the property must have a minimum of 70% of the front building façade located within 35 feet of the property boundary.
- 4. Parking located between the building and the street is prohibited.

Regarding 2 above, would Applicant consider specifying that the single access point is from Parklawn Drive?
