Ms. Byrne, I just got Celerico's schedule to start the concrete repairs and pervious paving repair / installation.

Attached is the funding letter Mike Hines and I put together. He is getting to a computer very soon today to sign.

I have updated the work to finish spreadsheet with the current information received in the last hour.

Work progress to date as of 4/16/2025

Curtis has cut the paving and has recompacted the excavation, inspected by Geolab and the WSSC inspector. Two feet of compacted soil was placed over the pipe and 30" of CR6 was added with 3" of paving to the base course level.

Curtis installed the "yard hydrant" water spigot in the open space area and it was inspected and approved by the WSSC yesterday. The WSSC will come back in the next few days to install the 5/8" water meter.

Jack Chuna has said he has to finish up another job and will be onsite to install the concrete sidewalk and curb repairs, and the pervious sidewalk, fixing the two spots that need repairs.

With the paving cut yesterday, Geolab and I wanted to verify that at least 5" of CR6 stone was placed below the paving on the lower half of the community which is in far better condition than the upper half. I will work with Josh and Greg on the remaining repairs required to the paving in the next few days so that when Celerico Concrete fixes the concrete curb, Cromwell Paving can repair the base and top coat the road.
