REQUEST FOR SUBPOENA

Pursuant to Office of Zoning and Administrative Hearings ("OZAH") Land Use Rules of Procedure Section 3.8, Party of Record Keith Nusbaum (the "Opposition") is submitting this request for a subpoena for the Montgomery County Planning Department ("MCPD") in the above referenced Local Map Amendment ("LMA").

I. STATEMENT OF GROUNDS FOR THE SUBPOENA

On or about July 29, 2025, a representative for Applicant informed the Opposition that Applicant and/or its representatives had been in contact with MCPD, prior to the submission of its application, regarding the details of the proposed application. On or about August 13, 2025, MCPD informed the Opposition that it had located at least 1,116 email correspondence items related to communications between MCPD and the Applicant or its representatives related to the not yet filed LMA for the time period of January 1, 2024, through the time of formal application submission with MCPD, approximately April 30, 2025.

These email correspondence items are relevant to the LMA and will contain information of evidentiary value in the currently scheduled LMA hearing. Specifically, the items relate to the Applicant's preliminary and current position on certain zoning regulations and the interpretation of those zoning regulations by MCPD. Those communications will likely provide the Opposition with potential exhibits to be introduced during the scheduled hearing. Furthermore, production of these email correspondence items at this point is necessary to determine who, if any, witnesses will be needed for the hearing scheduled for November 6, 2025.
