Hi Jeremy,

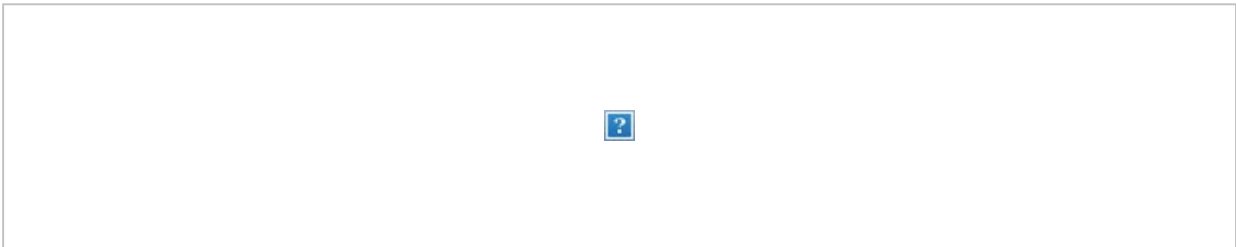
