- 4. Board voted unanimously to approve a letter of recommendation for selection of Mr. Kevin Finn and Dr. Thomas Clash to the Bethesda Transportation Management District Advisory Committee.

5. Guest Speakers

a. Joseph Moges, Assistant District Engineer, Maryland State Highway Administration; Matt Johnson, Capital Project Manager, Montgomery County Department of Transportation

CAB members asked Mr. Moges and Mr. Johnson questions about the decision-making, construction, and use of the new bike lanes on Old Georgetown Road between Beech Avenue and Rockville Pike.

Members raised issues including the apparent lack of public participation about this project, EMS lane use, alternate bike route consideration, budget, and the confusing traffic flow on

Old Georgetown Road caused by the bike lanes.

The speakers noted: Additional lane marking is still coming, the local speed limit will be reduced from 40 mph to 35 mph along Old Georgetown, and an evaluation study will be conducted. SHA will make more effort to reach out to the community.

Members of the public also submitted questions via the chat feature in Teams.

b. Peter Fosselman, Director of Regional Services
