- October 1, 2023, a bill was passed that enables trained shelter staff to administer rabies vaccines.
- Starting March 15, 2024, pet licensing is handled by Pet Data in Texas.
- Staff completed in-house defensive dog handling and dog attack training. Next will train volunteers.
- Sound proofing dog kennels: will be looking into sound testing before committing.
- Pet adoptions: results not as what we hoped for.
- Satisfaction survey: 91% / 100% for March!
- Community Cat Section now on website.

- Officers expected to engage with the community every day.
- Effective April 7, 2024, Spencer Kelly will be Acting Deputy Director while Deputy Director Lepiarz is on maternity leave.
