Action Items

Introductory Presentation

Mr. Pospisil opened meeting by welcoming new Airpark Community Advisory Committee (ACAC) members and community members in attendance. Each committee member took a minute to introduce themselves. Mr. Pospisil then gave a presentation to the ACAC that covered:

Election of Chair
