(1:46) Call to Order – Mr. Lazo called the meeting to order at 8:37 am.

April Meeting Minutes – approved without objection.

(3:44) Committee Updates

Health/Hospitality – Dr. Bruton reported that the Committee discussed the federal workforce crisis and what they were seeing in their respective industries. The group also discussed outreach to the refugee community and what additional or shifting of resources are needed to address the increase of unemployed or those looking for work.

- (15:21) IT/Life Sciences Mr. Hernández reported that the Committee discussed data sharing with workforce partners to better understand shared challenges and opportunities. The group also discussed the increase of job seekers expected in October when the federal worker "buy outs" expire.
- (16:43) Construction/Transportation Mr. Drury expressed that the industry is in need of electricians/electrical apprentices and the challenge with employers to hire or bring in pre-apprentices/students.
- (26:51) Youth/Young Adult Mr. Armstrong reported that the Committee discussed SummerRise and the upcoming closing ceremony. The committee also plans to update the charter and recruit a youth committee member.
- (30:34) New WIOA Out-of-School Youth Provider Vote Mr. Featherstone explained that WSM put out an RFP for WIOA Youth Services earlier in the year. Nine organizations responded and WSM hired a third-party to evaluate the proposals. Ultimately, Identity, Inc. was selected. The recommendation is to put Identity forward for a vote. As a result, their Executive Director, Diego Uriburu is resigning from the Board effective immediately to avoid any conflicts of interest. Identity, Inc. was approved unanimously by the Board to be the new WIOA OSY provider for FY26.
- (47:32) <u>ALICE Presentation</u>/Discussion Stephanie Crane & Scott Mengebier of the United Way of the National Capital Area provided an in-depth review and update on current ALICE data.
