Wayne Anderson noted that the proposed tower will be placed on the WSSC parcel on the driveway in front of the shelter, which is an ideal situation. Gerry Adcock asked Wayne if the shelter was set back far enough from the water tank, and Wayne confirmed it was.

Julie Elias summarized the application. She noted that the support structure for this application is a PEPCO pole that is scheduled to be replaced by PEPCO separate from the scope of work for this application. The proposed wireless installation will be attached to the future pole after it has been replaced. Gerry Adcock noted that conditioning the recommendation made sense. The committee concurred that the language of the condition should be that it is recommended on the condition the utility pole has been replaced with a 34' pole prior to the wireless installation.
