<b>Disruptive courtroom behavior or lack of attentiveness during court</b> (examples include walking around during court, not turning in phone, sleeping)	Verbal warning OR observe one additional docket the following week (depending on the severity of the disruption)	Observe two additional dockets the following week	Observe one additional docket per week for four weeks and complete writing assignment on what was learned during each docket (additional infractions will lead to community service increasing in increments of 8 hours)
<b>Failure to arrive to court with a completed tracking provided to you by case management</b>	Additional tracking due the following week	Observe two additional dockets the following week	Observe one additional docket per week for four weeks and complete writing assignment on what was learned during each docket (additional infractions will lead to community service increasing in increments of 8 hours)
<b>Failure to comply with housing</b> (examples include spending the night out without permission, loss of housing, concerning behaviors expressed by house members)	Two weeks of home confinement OR jail (depending on severity of the situation)	30 days of home confinement OR jail (depending on severity of the situation)	60 days of home confinement OR jail (depending on severity of the situation)
