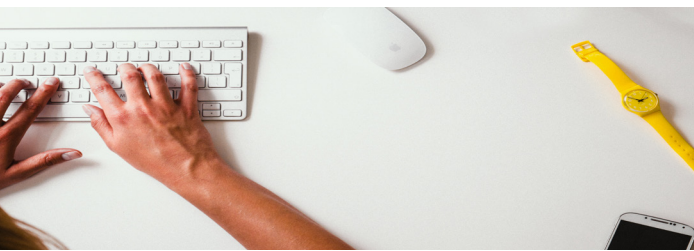

*The Maryland court system has four levels: two trial courts and two appellate courts. Each court has the authority to handle different types of cases. Montgomery County has two District Court locations and one Circuit Court.*

## District Court of Maryland

- Small claims (can range from \$5,000 to \$30,000)
- Domestic violence/peace orders
- Landlord-tenant disputes
- Return of property
- Some criminal cases
- Note: District Court does not conduct jury trials
