Montgomery County Public Schools Title I Part A Grant, \$2,863,919

I recommend that the County Council approve this supplemental appropriation in the amount of \$2,863,919 and specify the source of funds as State Grant.

Montgomery County Public Schools Title I Part A Grant, \$2,863,919

Background

- 1. Section 307 of the Montgomery County Charter provides that any supplemental appropriation shall be recommended by the County Executive who shall specify the source of funds to finance it. The Council shall hold a public hearing on each proposed supplemental appropriation after at least one week's notice. A supplemental appropriation that would comply with, avail the County of, or put into effect a grant or a Federal, State or County law or regulation, or one that is approved after January 1 of any fiscal year, requires an affirmative vote of six Councilmembers. A supplemental appropriation for any other purpose that is approved before January 1 of any fiscal year requires an affirmative vote of seven Councilmembers. The Council may, in a single action, approve more than one supplemental appropriation. The Executive may disapprove or reduce a supplemental appropriation, and the Council may reapprove the appropriation, as if it were an item in the annual budget.
- 2. The County Executive has requested the following FY23 Operating Budget appropriation increases for Montgomery County Public Schools:

3. This increase is needed because State funds are available for Montgomery County Public Schools to improve educational services at schools with high numbers of students from low-income families. The funds will be used for instructional materials, instructional staff, and summer programs for students.

- 4. The County Executive recommends a supplemental appropriation to the FY23 Operating Budget in the amount of \$2,863,919 for the Title I Part A Grant and specifies that the source of funds will be State Grant.
- 5. Notice of public hearing was given and a public hearing was held.

Part A Grant

Recommendation in Brief

Authorization is requested to receive and expend, subject to County Council approval, a Fiscal Year (FY) 2023 supplemental appropriation of \$2,863,919 for the FY 2023 Title I, Part A grant. Montgomery County Public Schools (MCPS) has received \$35,899,715 from the Maryland State Department of Education (MSDE) for the FY 2023 Title I, Part A grant. This award represents an increase of \$2,863,919 over the amount of \$33,035,796 included in the FY 2023 Operating Budget.

Background

MCPS currently operates programs under the Title I, Part A grant. The purpose of the grant is to provide schools with additional support to improve the teaching and learning for children at risk of not meeting challenging academic achievement standards, especially those children who reside in areas with high concentrations of children from low-income families. The additional allocation from MSDE is the result of scores calculated based on poverty and differentiation among schools, updates to selected measures, English Language Learner proficiency, and identification of Comprehensive Support and Improvement Schools and Targeted Support and Improvement Schools. There is a grant requirement to provide equitable services to students and teachers in nonpublic schools.

Support of Board of Education Mission

The Title I, Part A grant is supported by the Strategic Plan priorities of Academic Excellence and Well-being and Family Engagement, and it connects with the District Strategic Initiatives implementation of supporting the needs of students and families highly impacted by poverty. The focus of this grant is to provide additional support to schools with a high concentration of children from low-income families. The grant provides for additional staff, instructional materials, and summer programs for students. In addition, the grant provides supports for family and community engagement.

The grant activities will promote racial equity and social justice by focusing support of those highly impacted by poverty through the additional supports provided to schools with a high number of students impacted by poverty.

Use of Funds

Funds will be used to provide for—

- staff position salaries;
- instructional materials;
- other instructional costs; and
- associated employee benefits.

Recommended Resolution

WHEREAS, Montgomery County Public Schools has received notification from the Maryland State Department of Education that it will receive an additional \$2,863,919 for the Title I, Part A grant; now therefore be it

Resolved, That the superintendent of schools be authorized to receive and expend, subject to County Council approval, a supplemental appropriation of \$2,863,919 for the Title I, Part A grant in the following categories:
