- Holding individual meetings with all department employees to get to know them and to seek their input on ways to improve department operations and moral.

# **Principles of Ethical Conduct**

In order for government to effectively serve its community, the residents, businesses, and other stakeholders that interact with it must be confident that County business is conducted in a manner that is ethical and without improper influence. Montgomery County Ethics Law, codified in Chapter 19A of the County Code, exists to strengthen public trust by holding all public employees to a high standard of ethical conduct.

While these laws apply to all County employees, it is the expectation of the County Executive and Chief Administrative Officer that our executive level managers are models of ethical conduct. They are responsible to set the tone at the top by both ensuring that their actions comply with the County Ethics law and taking appropriate steps to avoid actual or even perceived conflict of interest, fraud, abuse, and waste in their areas of responsibility.

The full text of the ethics law, ethics regulations, and several educational resources can be found on the Ethics Commission website. You should familiarize yourself with County Ethics law, and below are provisions of the law that must be fully understood before beginning employment with Montgomery County Government.

- Employees are prohibited from participating in a matter that affects, in a manner distinct from its effect on the public generally, any property or business in which the employee has an economic interest. This also applies to any economic interest of an employee's relative, if the employee knows of their relative's economic interest. 19A-11(a)(1)
- Employees are prohibited from participating in a matter if the employee knows, or reasonably should know, that any party to the matter is a business 19A-11(a)(2):
  - (1) to whom the employee owes a duty of loyalty (by serving as an officer, director, trustee, or partner);
  - (2) in which the employee has an economic interest; or
  - (3) that, in the previous 12 months, the employee or their relative was employed by or owed a duty of loyalty to (by serving as an officer, director, trustee, or partner).
- The CAO and Ethics Commission must approve employment in any context outside of Montgomery County Government. 19A-12
- The misuse of prestige of office is prohibited. 19A-14
- The disclosure of confidential information and consideration of ex-parte communications is prohibited. 19A-15
- Employees are limited from the solicitation and acceptance of gifts. <u>19A-16</u>
