COUNCIL DECISION POINTS & COMMITTEE RECOMMENDATION

Public hearing and action. This item was introduced on June 27, 2023.

DESCRIPTION/ISSUE

The Council introduced an amendment to the FY23-28 Amended Capital Improvements Program (CIP) and supplemental appropriation of \$105,003 to the Montgomery County Public Schools (MCPS) FY24 Capital Budget for sustainability initiatives.

SUMMARY OF KEY DISCUSSION POINTS

- On June 16, 2023, the County Executive recommended the Council approve a supplemental appropriation totaling \$105,003.
- These funds, in the form of energy incentive rebates, are available to MCPS from EmPOWER Maryland, a statewide program that provides incentives for new construction and building improvements that are energy efficient and cost-effective.
- According to the Superintendent's memo, MCPS will use these funds to make energy efficient improvements in existing MCPS buildings.

Background

- 1. Section 307 of the Montgomery County Charter provides that any supplemental appropriation shall be recommended by the County Executive who shall specify the source of funds to finance it. The Council shall hold a public hearing on each proposed supplemental appropriation after at least one week's notice. A supplemental appropriation that would comply with, avail the County of, or put into effect a grant or a Federal, State or County law or regulation, or one that is approved after January 1 of any fiscal year, requires an affirmative vote of six Councilmembers. A supplemental appropriation for any other purpose that is approved before January 1 of any fiscal year requires an affirmative vote of seven Councilmembers. The Council may, in a single action, approve more than one supplemental appropriation. The Executive may disapprove or reduce a supplemental appropriation, and the Council may reapprove the appropriation, as if it were an item in the annual budget.
- 2. Section 302 of the Montgomery County Charter provides that the Council may amend an approved capital improvements program at any time by an affirmative vote of no fewer than six members of the Council.
- 3. The County Executive recommends the following capital project appropriation increases:

- 4. This increase is needed to offset the cost of energy efficient improvements made through this project as well as to support MCPS' efforts on energy savings. The recommended amendment is consistent with the criteria for amending the CIP because it leverages non-County sources of funds through the EmPOWER Maryland energy incentive rebates program.
- 5. The County Executive recommends an amendment to the FY23-28 Capital Improvements Program and a supplemental appropriation in the amount of \$105,003 for the Sustainability Initiatives Project Title (No. 652306) and specifies that the source of funds will be State Aid.
- 6. Notice of public hearing was given and a public hearing was held.

PROJECT DESCRIPTION

Maryland State law (Annotated Code of Maryland, *Education Article*, §5-312.1-School district energy policies) encourages school systems such as MCPS to set targets to reduce greenhouse gas emissions. The Montgomery County Climate Action Plan, released in June 2021, is a multi-year plan that includes many new requirements for construction, including electrification and restrictions on the use of natural gas. This project will provide funds to implement a variety of new capital projects to improve energy and utility use efficiency, reduce greenhouse gas emissions, improve resiliency, and align with other sustainability priorities for MCPS. An FY 2023 appropriation was approved to begin the evaluation of and provide funding for various sustainability features including: upgrades to automated building automation systems, building retrofits to improve energy efficiency, solar panel installations, renovating greenhouses, and support towards integrating sustainability features into academics. Due to fiscal constraints the amended FY23-FY28 CIP reflects a reduction in approved FY24 expenditures from \$7.5 million to \$5.0 million.

Subject: Fiscal Year 2023 Supplemental Appropriation Request for Sustainability Initiatives

Background

The Maryland General Assembly (General Assembly) has declared energy efficiency to be among the least expensive ways to meet the growing electricity demands of the state. This finding is repeatedly affirmed by national studies. Energy efficiency is widely regarded as the least costly energy resource option available today. Consistent with this declaration, the General Assembly passed the *EmPOWER Maryland Energy Efficiency Act of 2008*. EmPOWER Maryland is a statewide program that provides incentives for energy cost-effective new construction or existing building improvements. The incentive funds received by Montgomery County Public Schools (MCPS) through the EmPOWER Maryland program will be used for energy efficient improvements in existing MCPS buildings, which may also generate additional EmPOWER Maryland incentive rebates.

In that regard, EmPOWER Maryland energy incentive rebates in the amount of \$151,003, are available as a Fiscal Year 2023 supplemental appropriation to help offset the cost of energy efficient improvements and support the continued work of the Montgomery County Public Schools Sustainability Initiatives Capital Project.

Therefore, I recommend that the Board of Education approve the following resolution:

WHEREAS, EmPOWER Maryland energy incentive rebates in the amount of \$151,003, are available as a Fiscal Year 2023 supplemental appropriation to help offset the cost of energy efficient improvements and support the continued work of the Montgomery County Public Schools Sustainability Initiatives Capital Project; now therefore be it

Resolved, That the Board of Education request a Fiscal Year 2023 supplemental appropriation in the amount of \$151,003 for energy incentive rebates available through the EmPOWER Maryland program to support the Montgomery County Public Schools Sustainability Initiatives Capital Project; and be it further

<u>Resolved</u>, That a copy of this resolution be transmitted to the county executive and the Montgomery County Council; and be it further

Resolved. That the county executive be requested to recommend approval of this resolution to the Montgomery County Council.
