











HEATMAP OF RECIPIENTS






APPLICATIONS PER 1K RENTAL HOUSEHOLDS (BY ZIPCODE)





SHELTER RESIDENTS: AVERAGE DAILY COUNT BY WEEK




MC311 WEEKLY CALL VOLUME











VACCINATIONS: CHANGE OVER TIME AND BY AGE GROUP

ONE WEEK DELAY DUE TO TEMPORARY IMMUNET ISSUES






WEEKLY VOLUME BY PROVIDER (ALL DOSES)




VACCINATION GAPS AND DIFFERENTIALS BY GEOGRAPHY AND RACE/ETH



BY RACE/ETHNICITY: VAX GAP RELATIVE TO WHITE NH (12+)




BY RACE/ETHNICITY: FIRST DOSE VACCINATION RATES (12+)
