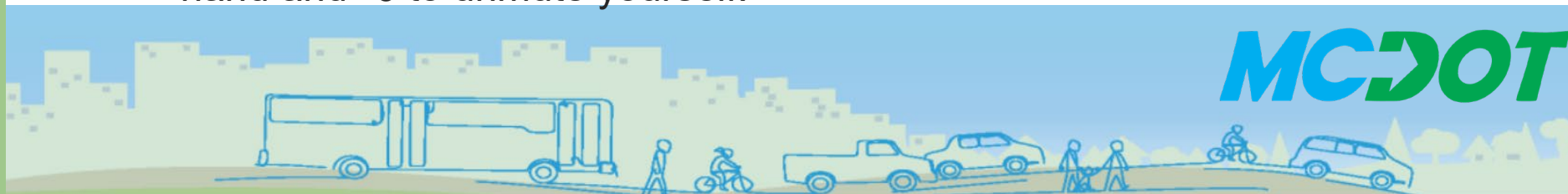
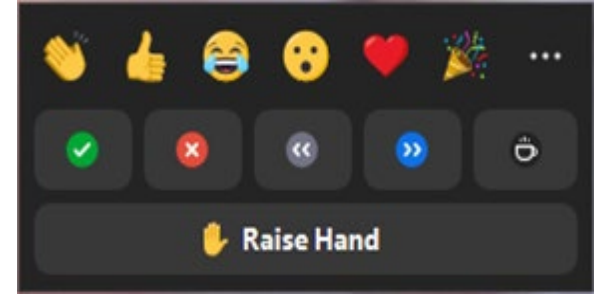

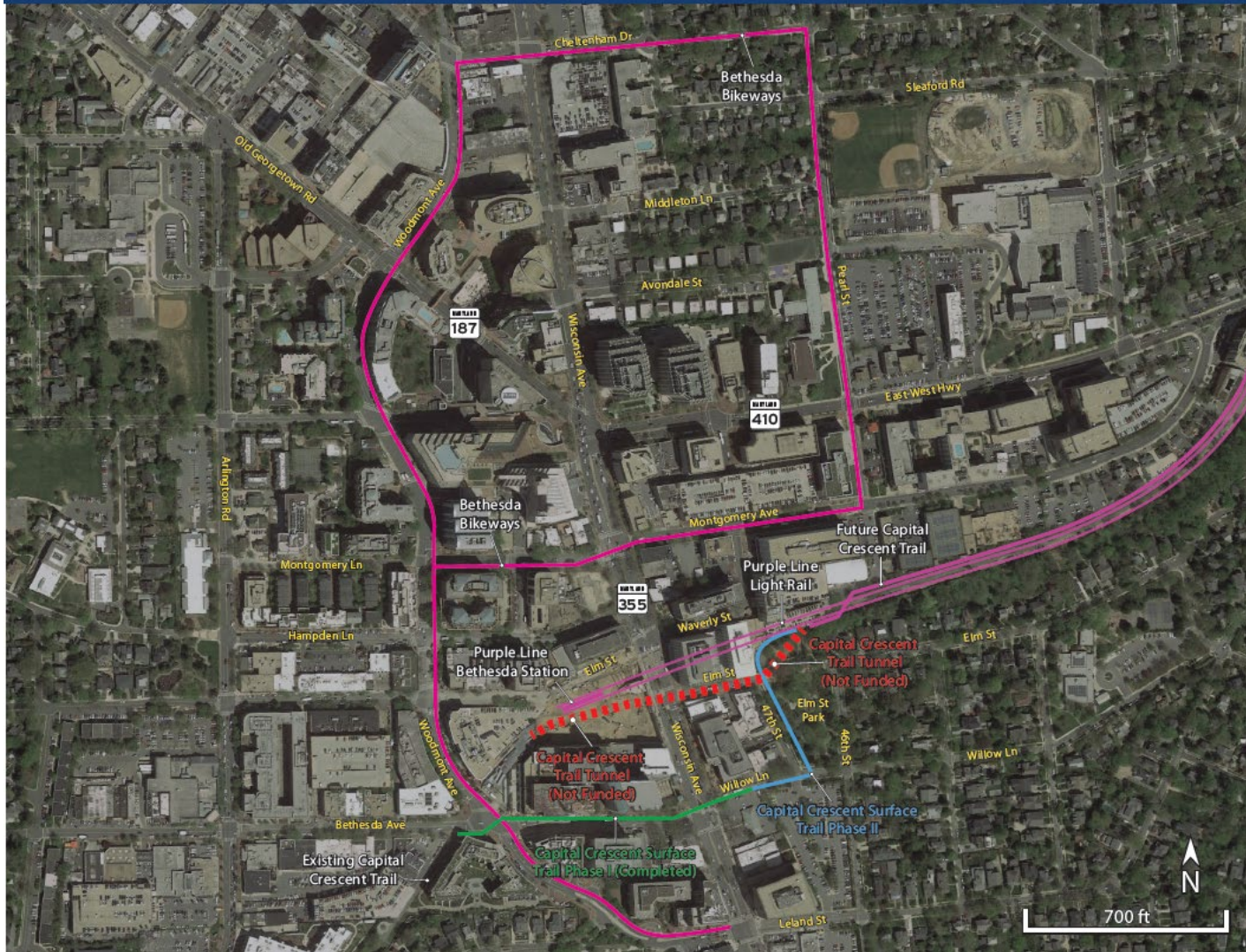

Capital Crescent Surface Trail Phase II Plan

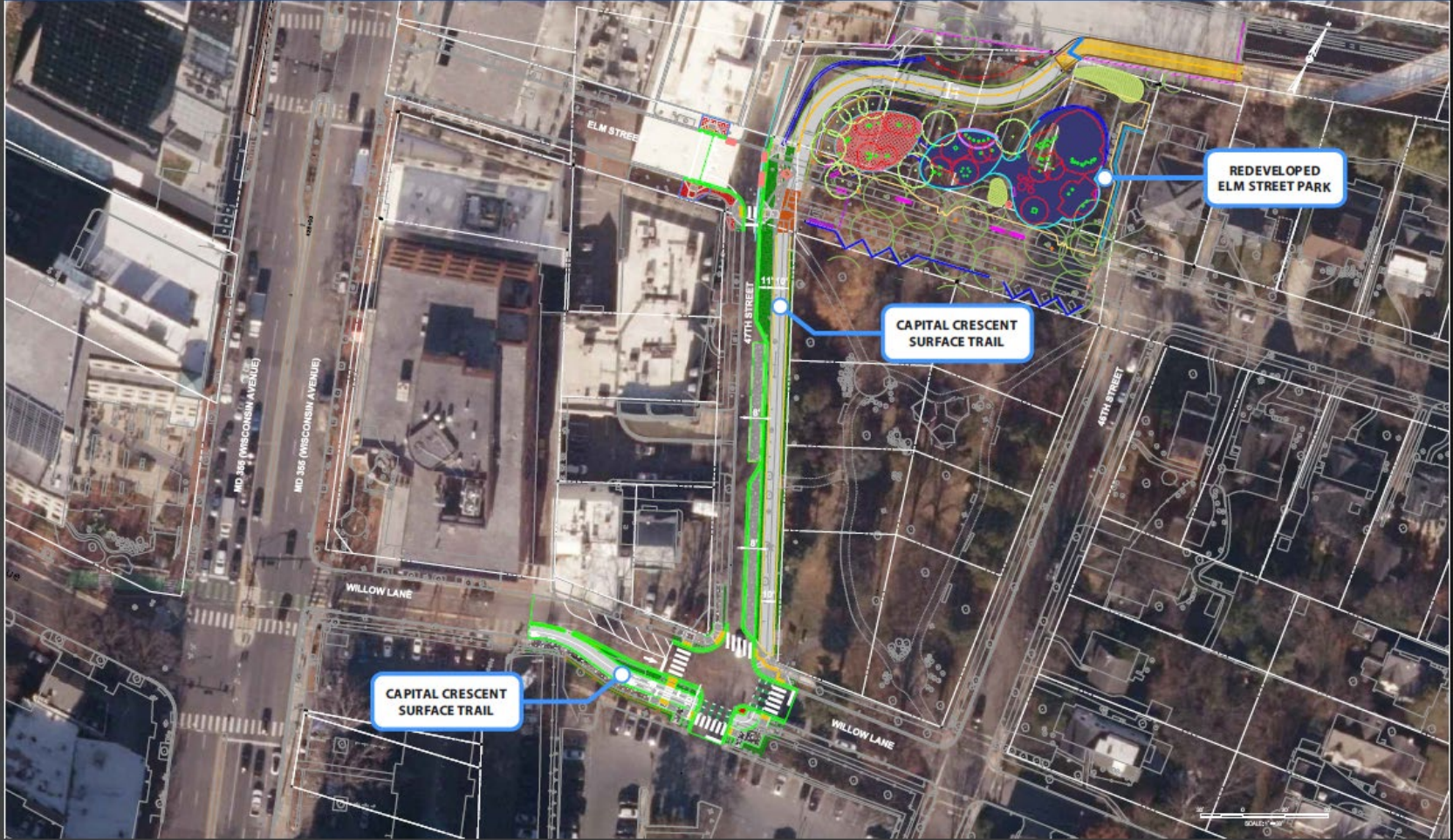


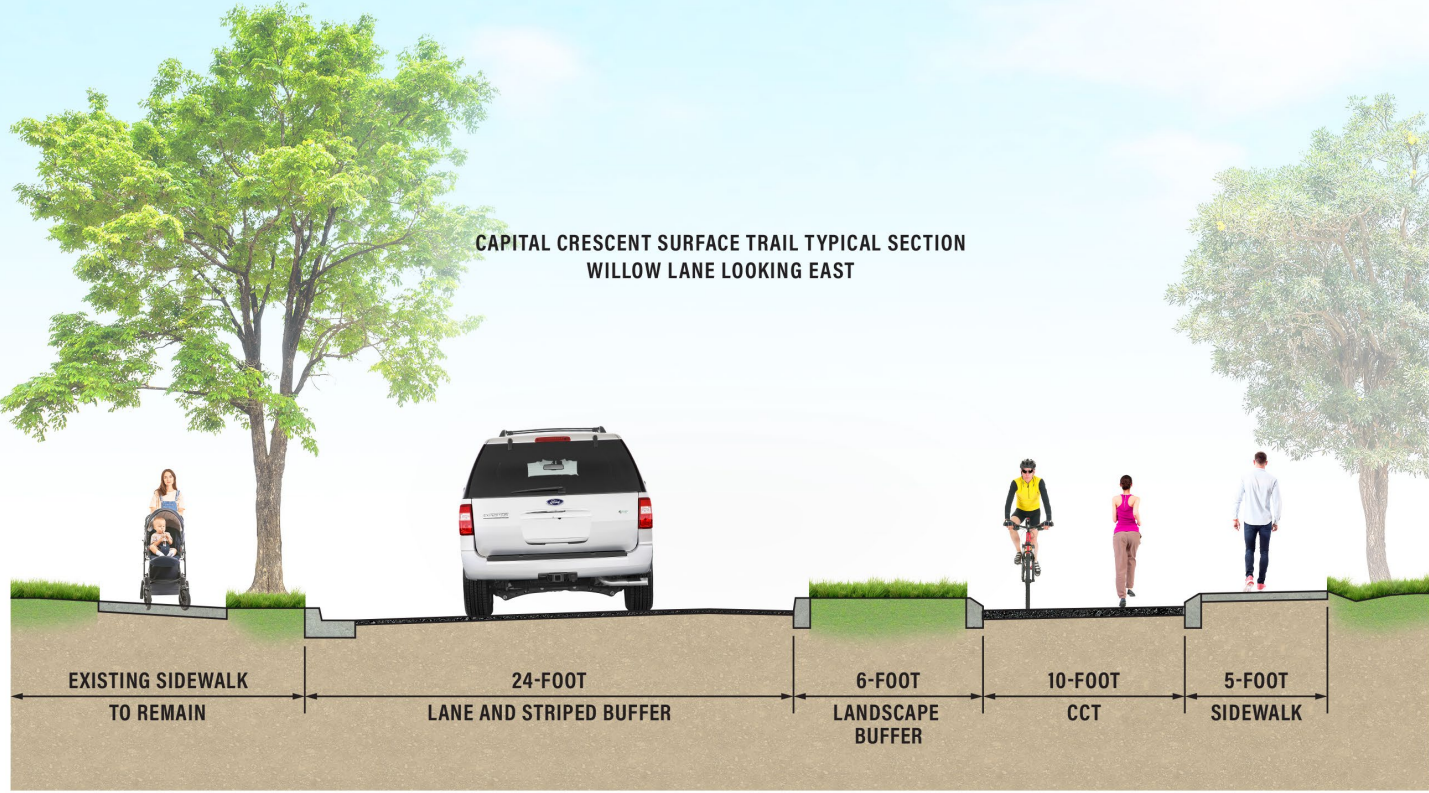

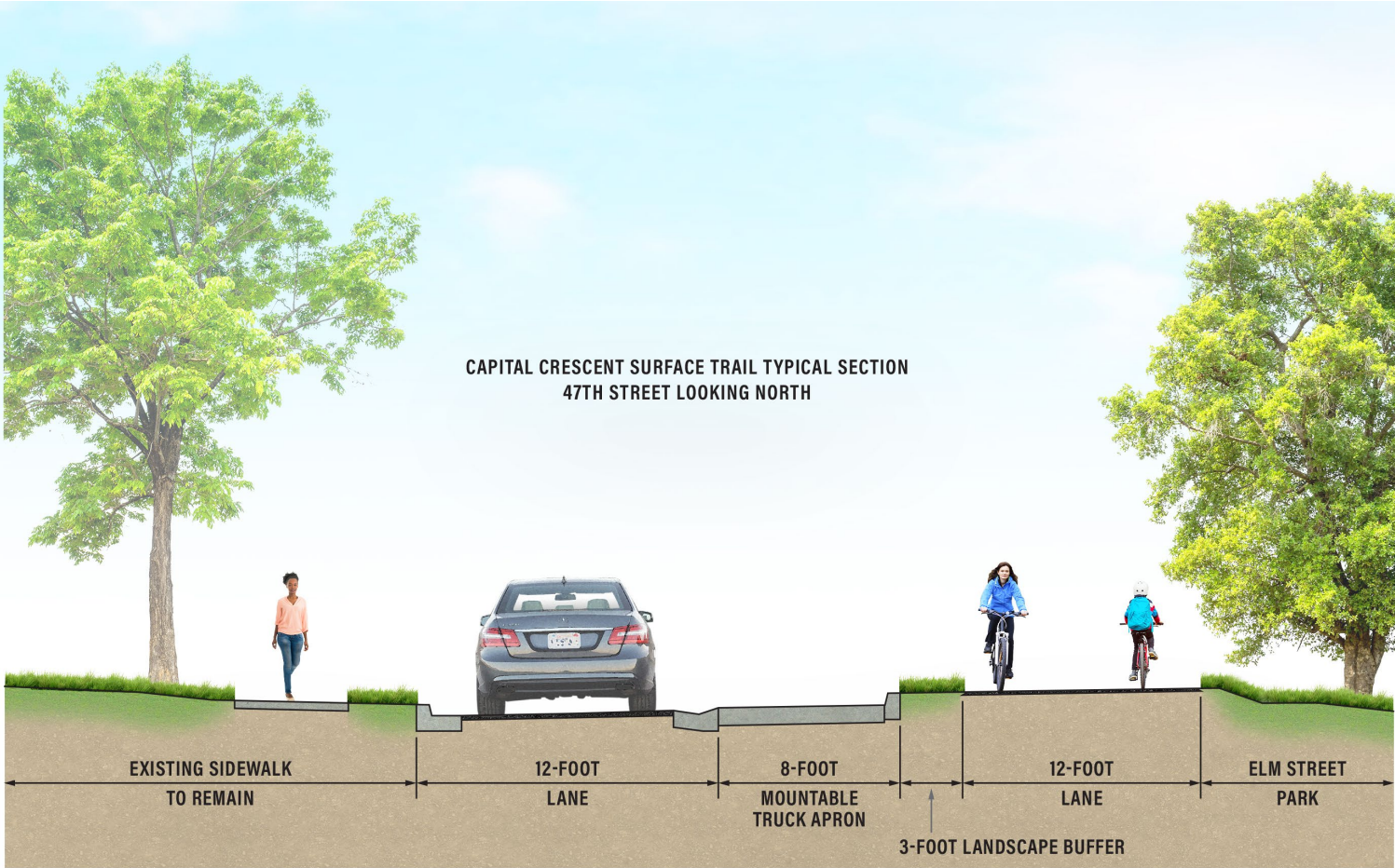

PROJECT JUSTIFICATION

COST AND ASSESSMENTS

- Total project cost currently estimated at \$2,600,000
- Project Cost includes:
 - Engineering
 - Land Acquisition-Easement from Town of Chevy Chase, M-NCPPC
 - Site Improvements
 - Utilities
 - Construction
- No properties are considered to be specially benefitted by the proposed improvement
