Edgar Neal,

At an upcoming virtual public hearing, residents will have an opportunity to present oral and/or written comments concerning the abandonment of a portion of public right of way covering approximately 3,043 square feet of property owned by Potomac Edison, Parcel P440 (the “Abandonment Area”), located along the west side of Frederick Road at the intersection of Brink Road in Clarksburg MD 20871, further depicted in the attached aerial and exhibit map.

MCDOT acquired perpetual easements from Potomac Edison for the construction of the Frederick Road Shared-Use Path Project, but the design was changed, and new easements were acquired. This abandonment is for the extinguishment of the sections of easements that are no longer needed and do not support the path.

The abandonment case was petitioned by The Montgomery County Department of Transportation – Division of Transportation Engineering (the “Applicants”). The petition seeks to abandon the Public Right of Way on the basis that there is no current or anticipated future public use for the property. The Montgomery County Department of Transportation (MCDOT) will hold the virtual public hearing on Thursday, July 13, 2023, beginning at 2:00 p.m. on the internet-based platform Zoom. Registration online is required to ensure participants receive an electronic invitation to the hearing. The public has until 5 p.m., Friday, July 7<sup>th</sup>, to register to participate in the hearing. Please see the following page for instructions.
