## 1 Introduction

The Montgomery County Department of Transportation (MCDOT) is preparing a *Corridor Summary Report* for the MD 355 Bus Rapid Transit (BRT) Planning Study located in Montgomery County, Maryland. The project is evaluating preliminary concepts for providing enhanced premium transit service along MD 355 from Bethesda to Clarksburg.

Phase 2 of the MD 355 BRT Study builds upon work completed in Phase 1, which developed Conceptual Alternatives that were evaluated to determine which should move forward for more detailed analysis. These alternatives have been refined and analyzed in further detail in Phase 2. The purpose of this *Community Effects Technical Report* is to describe the existing social and economic characteristics within the corridor and identify potential impacts associated with the implementation of the project. It also provides an overview of existing land use as well as future land use policies and growth management strategies within the MD 355 project study area. # 1.1 MD 355 BRT Project Purpose and Need

The purpose of the MD 355 BRT Planning Study is to provide a new transit service with higher speed and frequency along MD 355 between Bethesda and Clarksburg. The purpose and need statement has been consolidated into four distinct goals to guide the development of alternatives and as a framework for comparing alternatives:

- Goal 1. Provide an appealing, functional, and high-quality transit service
- Goal 2. Improve mobility opportunities, accessibility, and transportation choices
- Goal 3. Support planned development
- Goal 4. Support sustainable and cost-effective transportation solutions

# 2 Alternatives






Figure 2-2: Alternative A

Five alternatives, including the No-Build Alternative, are being evaluated as part of Phase 2 of the MD 355 BRT Planning Study and will be summarized in the *Corridor Summary Report*. The four Build Alternatives are shown in **Figures 2-2 through 2-5**.



This *Community Effects Assessment* prepared in support of the *Corridor Summary Report* assesses existing conditions and the changes in the community and socioeconomic characteristics of the MD 355 corridor and potential effects associated with each alternative.

#### 2.1.1 No-Build Alternative

The No-Build Alternative would include no additional infrastructure improvements other than those already planned and programmed, including the Ride on extRa service launched in October 2017 from the Medical Center Metro Station to Lakeforest Transit Center. This service includes Transit Signal Priority (TSP) at key locations along the route.

# 2.1.2 Transportation System Management (TSM) Alternative

The TSM Alternative would consist of enhanced bus service operating in mixed traffic using existing lanes from the Bethesda Metrorail Station to Clarksburg along MD 355 and along Clarksburg Road to the Clarksburg BRT terminus.

This Alternative would extend the Ride On extRa service south from the Medical Center Metro Station to Bethesda and north from Lakeforest Transit Center to Clarksburg and would include additional TSP and stops along the route. The service would also transition from a peak period-only service to an all-day span of service.

#### 2.1.3 Alternative A

Alternative A would incorporate elements of the TSM Alternative plus additional elements to create a BRT service with limited infrastructure improvements. Alternative A would consist of BRT service, operating in mixed traffic using existing lanes from the Bethesda Metrorail Station to Clarksburg along MD 355. In Segment 7, the BRT would travel along Middlebrook Road to Observation Drive, Goldenrod Lane, Germantown Road, then back to Observation Drive to Ridge Road, and across MD 355 to Snowden Farm Parkway to Stringtown Road to the BRT Terminus at Clarksburg.

Alternative A would include additional TSP along with queue jumps at key locations along the route. It would also include off-board fare collection, all-door boarding, level boarding, articulated buses, and Flash branding.

#### 2.1.4 Alternative B

Alternative B would generally operate in dedicated median lanes where feasible and in mixed traffic in Segments 1 and 7. In Segment 7, the BRT would travel along Middlebrook Road to Observation Drive, including the unbuilt portion, to Stringtown Road to the BRT Terminus at Clarksburg.

Alternative B would include additional TSP at key locations along the route, off-board fare collection, all-door boarding, level boarding, articulated buses, and Flash branding.






Figure 2-3: Alternative B







Figure 2-4: Alternative C





#### 2.1.5 Alternative C

Alternative C would generally operate in dedicated curb lanes where feasible. In Segment 7, the BRT would operate in mixed traffic along MD 355 from Middlebrook Road to the BRT Terminus at Clarksburg, via Clarksburg Road and Stringtown Road.

Alternative C would include additional TSP along with queue jumps at key locations along the route. It would also include off-board fare collection, all-door boarding, level boarding, articulated buses, and Flash branding.

## 2.2 Alignment Segments


Due to the existing conditions that vary along MD 355 as the roadway transitions from an urban environment in downtown Bethesda to a suburban setting in Clarksburg, the corridor was divided into seven segments during Phase 1 of this study which have been carried forward into Phase 2. The segments were primarily geographically based with each having its own set of characteristics, opportunities, challenges, and constraints. The seven segments geographic descriptions are listed in **Table 2-1** and shown below in **Figure 2-5**.

Given the length of the corridor and its varying characteristics and uses, it is expected that a Recommended Alternative would be constructed in stages. In addition, a Recommended Alternative could be pieced together from segments of different alternatives to form a "hybrid" Recommended Alternative. In order to facilitate the identification of a Recommended Alternative, the alternative benefits and impacts have been quantified, as appropriate, based on the seven roadway alignment segments and are presented in **Chapter 5.**

#### 3 Social Characteristics

Data for population and housing comes from the 2016 Five-Year American Community Survey. Demographic data was derived from Census Block groups which generally intersect and approximate the composite half-mile buffer of the study alternatives (Figure 3-1).

## 3.1 Demographics

#### 3.1.1 Population

The estimated number of residents within the Study Area is 253,645. See **Appendix A** for detailed data tables.

#### 3.1.2 Racial and Ethnic Characteristics

Overall, 57 percent of the population in the study area is white. Black or African Americans account for approximately 15 percent, and Asians account for 17 percent. Less than 1 percent are American Indians, Alaskan Natives, Hawaiians or Other Pacific Islanders. Those who identify themselves as "Other" or "Two or more races" make up 6 percent and 5 percent respectively.

# 3.1.3 Distribution by Age, Gender, and Disability


There are fewer men than women living in the study area. According to the data, 48.7 percent of the population is male and 52.3 percent is female. This is slightly different than when compared to the state of Maryland where 48.4 percent of the population is male and 51.6 percent is female and in Montgomery County, where 48.2 percent are male and 51.8 percent are female.

The 19 and under age group ranges from a low of 0 percent to a high of 37.1 percent across the study area Census Block Groups. The 20 to 24 years group ranges from a low of 0 percent to a high of 22.5 percent. The 25 to 34 years group ranges from 0 percent to 50.9 percent. The 35 to 44 years group ranges from 0 percent to 26.9 percent. The 45 to 54 years group ranges from 0 percent to 25.3 percent. The 55 to 64 years group ranges from 3.6 percent to 26.2 percent. The 65 and over age group ranges from 0 percent to 46.2 percent.

The percentage of residents with a disability ranges from a low of 3.6 percent to a high of 26.9 percent.

#### 3.1.4 Income Levels

Montgomery County's median household income is estimated to be \$100,352, which is substantially higher in comparison to the same measure for the State of Maryland (\$76,067). According to the census data, 46 percent of the study area's population makes between \$100,000 and \$200,000 or more. See **Appendix A** for data tables.

The percentage of residents in the study area characterized as being below the poverty line in the past 12 months is approximately 8 percent. This is slightly higher than for the entirety of Montgomery County where the percentage is 6.9 percent. The percentage of the population in Maryland below the poverty level is 9.9 percent which is higher than the county and the study area.

#### 3.1.5 Housing

The percentage of **owner** occupied housing ranges from 0 percent to 100 percent, with an average of 58.3 percent. The percentage of **renter** occupied housing ranges from 0 percent to 100 percent with an average of 40.9 percent.

Montgomery County has had a moderately priced housing law since 1974, which generally requires that between 12.5 percent and 15 percent of housing units (in new subdivisions with 20 or more total units) be moderately priced dwelling units (MPDUs). As a result of this policy, over 15,000 privately developed affordable housing units have been constructed in the county between 1976 and 2016.

The Montgomery County Department of Housing and Community Affairs Office maintains a listing of current MPDUs available for rent. # 3.2 Environmental Justice (EJ)

On Feb 11, 1994, Executive Order 12898, Federal Actions to Address Environmental Justice in Minority Populations and Low-Income Populations, was signed by President William J. Clinton. The order directed federal agencies to develop environmental justice strategies to help federal agencies address disproportionately high and/or adverse human health and environmental effects of their programs on minority and/or low-income populations. The order is also intended to promote nondiscrimination in federal programs that affect human health and the environment. It aims to provide minority and low-income communities access to public information and public participation in matters relating to human health and the environment.

A **minority** is defined as a person who is Black, Asian, American Indian, Alaska Native, Native Hawaiian, Other Pacific Islander, Hispanic, or Latino.

A **low-income** person is defined as a person whose median household income is at or below the Department of Health and Human Services poverty guidelines. These are issued annually and reflect price changes for the previous calendar year. 2018 Poverty Guidelines for the 48 contiguous states and the District of Columbia are calculated by the number of persons in the household. The threshold for a single person household is \$12,140. According to the Federal Register, these figures are derived from the Census Bureau's current official poverty thresholds.

# 3.2.1 Methodology

The following summarizes the approach for identifying EJ communities within the project boundaries.

- 1. The team obtained 2012 to 2016 American Community Survey data (latest five-year average) at the census block group level.
- 2. A one-half mile buffer from the centerline of each alternative was established and the buffer areas for each alternative were then merged to create a composite study area encompassing 142 census block groups.
- 3. Reference geographies were then identified (**Table 3-1**) to assist in recognizing applicable thresholds and to provide comparable data to evaluate study area characteristics.

# 3.2.2 Identifying Minority Populations within Study Area

Non-Hispanic or Latino, White Alone population ACS Data (B03002) was analyzed to determine the total minority population and the Percent Minority Population by census block group. The percent minority population for the study area was determined to be 55.6 percent. Reference geographies were also reviewed to ensure the evaluation of EJ populations were representative of broader trends in the region. The lowest percent minority population was identified as 47.5 percent for the state of Maryland. All other comparable reference geographies exhibited a greater than 50 percent minority population.

Therefore, census block groups with greater than 47.5 percent minority population were characterized as a potential EJ population to ensure representative consideration of minority populations


# 3.2.3 Identifying Low-Income Populations within Study Area

Poverty Status of Individuals ACS data (B17021) was analyzed to determine low-income populations by census block group. To determine the Meaningfully Greater threshold, the team used the lowest reference group statistic representative of Montgomery County (**Table 3-1**), plus 0.75 percentage points higher (spread between lowest and highest minority reference statistics divided by four).

Therefore, census block groups with greater than 7.7 percent of individual population below poverty level are characterized as meaningfully greater and identified as a potential EJ population.

## 3.2.4 Findings

Based on the 2012 to 2016 data there are 79 block groups that meet the threshold of 47.5 percent minority populations.

There are 43 block groups that meet the low-income population threshold of 7.7 percent. **Figure 3-1** illustrates the combined EJ data. See **Appendix A** for the data tables.

At this stage of project development, EJ considerations were most applicable to the identification of BRT stations locations to ensure equitable access along the corridor.

Environmental justice populations will continue to be considered in future project phases including design, construction, and operation. Final design activities will identify potential direct impacts on environmental justice communities related to project design and construction staging. Targeted outreach may be necessary to better understand potential effects to environmental justice populations and to identify ways to avoid or minimize those effects so that these communities are not disproportionately impacted.

# 4 Community Facilities and Services

## 4.1 Educational Facilities and Libraries within the Study Area

There are 27 public schools located within one-half mile of the study alternatives (**Table 4-1 and Figure 4-1**). Additionally, there are 44 other, private education facilities within the study area with the majority providing preschool and early elementary instruction. Larger, private schools providing secondary instruction (e.g. grades 9-12) within the study area include the Avalon School (Gaithersburg), the Yang Academy (Gaithersburg), the Charles Smith Jewish Day School (Rockville), the Georgetown Preparatory School (North Bethesda), the Academy of the Holy Cross (Kensington), and the Stone Ridge School of the Sacred Heart (Bethesda).

Figure 4-1: Public Schools







Figure 4-2: Health Care Facilities

# 4.4 Emergency Services and Law Enforcement

The study area is served by two public police stations and eight fire/emergency service stations (**Table 4-4** and **Figure 4-3**). The City of Gaithersburg also has a police service housed within the corridor. County-based police administration buildings in the corridor include the Office of Internal Affairs in Gaithersburg and the Montgomery County Sheriff's Department in Rockville. Quasi-public (facility-based) fire and police units also serve the National Institute of Health in Bethesda.



# 4.5 Publicly Owned Public Parks and Recreational Facilities

Founded in 1927, the Maryland-National Capital Park and Planning Commission (M-NCPPC) is a bi-county agency serving Prince George's and Montgomery counties. In Montgomery County, the Department of Parks, the Planning Department, and the Planning Board work in cooperation with M-NCPPC to manage parks and recreation areas. Within the study area M-NCPPC manages ten of the major parks, two are owned by the City of Gaithersburg, four by Rockville, and one, Seneca Creek State Park, is owned by the State of Maryland (Table 4-5 and Figure 4-4). Recreation centers within the study area provide a variety of services for youth through elderly citizens (Table 4-6 and Figure 4-4.)



#### 4.6.2 Post Offices

The Rockville Post Office on North Washington Street and the Bethesda Post office on Wisconsin Avenue are adjacent to MD 355 in the study area.

# 4.7 Public Transportation

Public transportation along or adjacent to the MD 355 corridor includes the Washington Metropolitan Area Transit Authority's (WMATA) Metrorail Red Line, the MARC Brunswick Line, and Amtrak's Capitol Limited Line. Both are accessible at the Rockville Metrorail Station. The MD 355 BRT corridor parallels the western branch of the Red Line from the Bethesda Metrorail Station to the Shady Grove Metrorail Station. WMATA Metrorail stations within the project corridor include Bethesda, Medical Center, Grosvenor-Strathmore, White Flint, Twinbrook, Rockville, and Shady Grove.

Bus service along the MD 355 corridor is provided by three operators: WMATA's Metrobus, Montgomery County's Ride On, and MTA's commuter buses. Sixty-three bus routes operate on or cross the MD 355 study area: 45 are operated by Ride On, 14 are operated by WMATA, and four are operated by MTA Commuter Bus.

Currently, Metrobus does not serve the full length of the MD 355 corridor. Nine Metrobus Routes (C4, C8, J1, J2, J3, J4, J7, J9, T2) serve MD 355 intermittently between the Washington, D.C. border and the Rockville Metrorail Station. Five Metrobus Routes (Q1, Q2, Q4, Q5, Q6) serve MD 355 intermittently between the Wheaton and Shady Grove Metrorail Stations. Approximately 28,500 passengers travel these bus routes daily. Most people get on and off at the Rockville Metrorail Station, Montgomery College, and the Shady Grove Metrorail Station.

Of the 45 Ride On bus routes that operate on MD 355 or cross the corridor, there are six routes that operate a significant portion of their alignment on the corridor (46, 55, 73, 75, 79, 101). Approximately

12,500 passengers travel these six bus routes on MD 355 corridor daily. However, none of these routes serve the full length of the corridor. Ride On Route 46 and Route 55 are the local routes with the most significant overlap with the corridor. Route 46 travels between the Walter Reed National Military Medical Center (Medical Center) and Montgomery College Rockville Campus. Route 55 travels between the Rockville Metrorail Station and the Germantown Transit Center. In October 2017, Ride On introduced a new service called Ride On extRa (Route 101). This limited-stop service operates between the Lakeforest Transit Center and the Medical Center via MD 355 every ten minutes during the weekday peak periods.

MTA's MARC Brunswick Line crosses the proposed project corridor. The Rockville MARC Station is located adjacent to the Rockville Metrorail Station. Other MARC stations which are not directly located along MD 355 but serve corridor residents include Germantown, Metropolitan Grove, Gaithersburg, Washington Grove, Garrett Park, and Kensington.

Two park and ride lots are located within the project corridor. The Milestone Park and Ride is located near the northern terminus in north Germantown. The Montrose Park and Ride, also known as the Mid-Pike Plaza Park and Ride, is in Rockville, just north of the White Flint Metrorail Station.

There are also two regional transit centers (not directly liked to Metrorail stations) within Montgomery County that provide additional bus transit access: the Lakeforest Transit Center and the Germantown Transit Center. Both facilities serve as important linkages between regional bus service, especially for the northern half of the study area where Metrorail service does not operate. The Lakeforest Transit Center also provides parking.

#### 5 Land Use and Master Plans

# **5.1** Existing Land Use

Existing land use along the corridor is diverse and includes residential, commercial, and institutional development, as well as a significant amount of open space (**Table 5-1 and Figure 5-1**). Agriculture and forest land cover are predominantly found in the northern portion of the study area, generally north of Germantown. Large forested areas are also associated with the Great Seneca Creek and Rock Creek stream valleys. South of Germantown, the corridor is more developed with mixed land use dominated by medium and high density residential use interspersed with commercial and institutional uses. The Lakeforest Mall and Montgomery Village Crossing retail centers anchor a large area of commercial land use in the central portion of the corridor in Gaithersburg. Large institutional uses in the southern portion of the corridor include the Shady Grove Metrorail Station and the National Institutes of Health in Bethesda.



#### 5.2 Master Plans

The following section summarizes various plans that have been approved or are in progress within the corridor to manage growth and accommodate BRT.

#### 5.2.1 White Flint

The White Flint Sector Plan of 2010 covers MD 355 from Hillery Way to Hoya Street. Most of this sector consists of commercial and office land uses, including the White Flint Mall property, which is planned to be redeveloped as a mixed-use property. The White Flint 2 Sector Plan of 2017 focuses on land use, density and mobility options for 460 acres located between three areas: City of Rockville, Twinbrook, and White Flint. It also envisions improved pedestrian and bicyclist access along MD 355 and a BRT system that would support proposed developments to make White Flint the main urban center for northern Bethesda.

The Plan acknowledges the capacity constraints of Rockville Pike and Nicholson Lane and includes the possibility of grade-separating the intersection and proposes an expansion of the local street network to support the major arterials. Recommendations include extending Chapman Avenue to Huff Court to provide a local circulation alternative to Rockville Pike and extending Executive Boulevard to cross Rockville Pike and connect with Huff Court. Transit circulation to connect major activity centers in the area is also proposed.

#### 5.2.2 Twinbrook

The Twinbrook Sector Plan was approved and adopted in January 2009. The area is envisioned as a "community of employment, residential, retail and technology uses in an urban environment." There are three mutually supportive districts. The Metro Core Area is planned as an area of mixed uses focused on the Metro station. The Technology Employment area also has mixed-use, but the focus is on advanced technology and biotechnology activities and high quality public design. The Light Industrial area encompasses the area around Carroll and Wilkins Avenues. Goals include recreating Twinbrook as a walkable place with safe and direct access to adjacent Metro stations and to surrounding parkland with street front uses that create convenience and activity while building on the established employment base by zoning for technology uses; and implementing urban parks, urban design, and environmental standards that can shape urban patterns and scaled development.

# 5.2.3 Rockville

The current City of Rockville's Master Plan was completed in November 2002 and is subdivided into Planning Areas, as established in the 1970 Master Plan. MD 355 traverses Planning Areas 1, 5, 9, and 17. Currently, the city is in the process of a 2040 Master Plan Update and is expected to be ready for implementation in the Summer of 2019. The following provides additional details.

Planning Area 1, The Rockville Town Center, is located along MD 355 between Frederick Avenue and Richard Montgomery Drive. This area is proposed as the urban core of the city. It contains mixed-use and commercial land uses along MD 355, with heavier densities concentrated near the Rockville Metrorail



Station. The Plan focuses on pedestrian and bicycle access through the Town Center and convenient access to the Metrorail Station.

Planning Area 17 includes the King Farm mixed-use development and Planning Area 5 covers MD 355 between College Parkway and Frederick Avenue.

The Metrorail tracks abut MD 355 along the east side, and Montgomery College and general commercial areas are located to the west. The Master Plan proposes commercial land use to the east, between Mannakee Street and Frederick Avenue, and mixed-use residential to the west, transitioning to the Town Center.

The southern portion of MD 355 through Rockville crosses Planning Area 9, from Richard Montgomery Drive to Bou Avenue, just north of Hoya Street. Retail uses are more than half of the existing developed land within the corridor and increases in density as one travels south along MD 355. In general, the Plan maintains the commercial corridor with mixed-use development in the surrounding area, particularly near the Twinbrook Metrorail Station, which is being considered for transit-oriented development. The Plan also focuses on the development and improvement of the local roadway network to alleviate congestion along the MD 355 corridor and envisions MD 355 as a multi-lane boulevard that would accommodate a Bus Rapid Transit (BRT) system.

The 2016 Rockville Neighborhood Plan updates the 2002 plan and replaces the 1989 Rockville Pike Neighborhood Corridor Plan. It establishes the vision for how Rockville's portion of the Rockville Pike corridor and adjoining areas can be "transformed from an architecturally non-distinctive suburban retail strip into an attractive and vibrant neighborhood for shopping, living, and working". Implementation of the plan is expected to broaden the Pike's appeal from an auto-oriented retail strip to one with a range of transportation options, as well as new housing and retail establishments.

# 5.2.4 Shady Grove

The Shady Grove Sector Plan was adopted in 2006 and includes frontage on MD 355 between College Parkway and O'Neill Drive. This section is primarily industrial, with office/industrial park and minor commercial land uses in the southern section. The east side of MD 355 between Paramount Drive and Kings Farm Boulevard has the greatest potential for redevelopment. The Plan envisions mixed land uses in the south to promote housing opportunities, and an urban village with transit-oriented development surrounding the Shady Grove Metrorail Station. Currently a minor master plan amendment is being advanced to address changes in transportation policy (including both highway and transit-BRT initiatives) and development staging.

#### 5.2.5 Gaithersburg

The City of Gaithersburg developed their Master Plan in 2009. It divides MD 355 into three sections, based on the surrounding land uses.

The Southern Residential District, which is primarily medium and low-density residential, with a mix of commercial, office, and research land uses from Shady Grove Road to Summit Avenue. The Fairgrounds



Commercial District, which is predominantly commercial office, with some residential pockets from Summit Avenue to MD 124, which is the most developed of the three sections and the most constrained in terms of available right-of-way for future roadway widening and improvements. The Northern Employment District is a mixture of commercial, research, and industrial land uses from MD 124 to Ridge Road.

The City completed its own independent BRT study in September 2015 to evaluate potential transit treatments along MD 355 and alternate routes through the City of Gaithersburg. In addition to implementing BRT along MD 355, the City is also investigating the potential for a local circulator to encourage residents and visitors to get out of their cars and take transit instead.

#### 5.2.6 Germantown

Germantown has two Master Plans in place. The 1989 Master Plan, which encompasses areas east of MD 355, and the 2009 Employment Area Sector Plan, which includes areas to the west.

The 1989 Master Plan increased the amount of commercial land use in Germantown by approximately 99 percent compared to the 1974 Master Plan. The current plan also proposes an increase of 12.8 percent institutional uses and 5.5 percent residential uses. Within the Germantown boundaries there are two villages that front MD 355: Neelsville Village from Brink Road to MD 118 and Middlebrook Village from MD 118 to Seneca Park.

Neelsville Village has approximately 431 acres of residential and 167 acres of mixed-use and highway commercial land uses. The residential areas are primarily single-family homes. Mixed-use development is found in Milestone Center, a regional mall with access from MD 355 with up to 1.2 million square feet of retail space, as well as 153 acres of residential, and 10 acres of office building and commercial uses. Further south on MD 355 is the Fox Chapel Center, another retail area surrounded by a variety of businesses and a mobile home park.

With the approval of the 2009 Employment Area Sector Plan the number of dwellings allowed were increased by 157.4 percent and the commercial land use by 29.9 percent. Three sections within the 2009 Master Plan front MD 355: Seneca Meadows Milestone, an industrial development area, Montgomery College which plans to expand their facilities to over a million square feet and re-zone the entire property, and Fox Chapel, which envisions MD 355 as a gateway to the town.

# 5.2.7 Clarksburg

The Clarksburg Master Plan was updated in 2011 as part of a limited Master Plan Amendment to allow the construction of a new grocery store and other ancillary uses. The Town Center is the northern terminus of the MD 355 BRT study and is located between Redgrave Place and Stringtown Road. It is primarily a residential area with a few small businesses, including a couple of restaurants and the Clarksburg Animal Hospital. The Master Plan envisions a major transit stop, as well as additional transit-oriented development near Redgrave Place in the future. It also proposes the relocation of MD 355 to avoid future widening to maintain the Town Center District's current character.

The Transit Corridor District extends from Stringtown Road to Old Baltimore Road and is predominantly residential, with single-family detached homes fronting on MD 355. This section of MD 355 is expected to remain an arterial roadway, with a maximum typical section of four-lanes divided by a planted median. Observation Drive would serve as an alternative north-south roadway for this section.

The Brink Road Transition Area in the southernmost section of the Clarksburg Master Plan, extends from Old Baltimore Road to Brink Road. It is predominately residential, with single-family homes east of MD 355. West of MD 355 is the Goddard School and single-family homes.

# 6 Impact Assessment

The following sections assess the potential impacts of the alternatives on the communities along the corridor. Measures of Effectiveness (MOEs) were developed to evaluate the alternatives, assessing how the alternative performs and its effects on the environment. The MOEs that evaluate potential impacts to existing social and economic characteristics within the corridor are summarized below. They include impacts to transit operations, circulation, adjacent/parallel/intersecting roadways, parking, property and community facilities.

Temporary impacts along the corridor during construction would include partial road closures, traffic detours, and the dirt, noise and heavy equipment traffic that typically accompany any construction project.

# **6.1** Transit Operations

# 6.1.1 BRT Boardings and Daily Transit Ridership




Figure 6-1: Total Daily Transit Boardings by Alternative, By Mode (2040)

Alternative B would result in the highest weekday daily BRT boardings at 30,000 per day. Alternative C is next at 27,900, followed by Alternative A at 25,000. Ridership is shown in **Figure 6-1**.

Total daily weekday transit boardings, including local bus and Metrorail, would be the highest in Alternative B, at 91,900. This is approximately 16,000 more boardings per day than in the No-Build Alternative. The next highest would be Alternative C, at 89,400 total boardings, followed by Alternative A at 87,400. Each of the Build Alternatives would attract a large number of local bus riders, as shown by the much smaller number of local bus riders when compared to the No-Build Alternative and would have minimal impact on Metrorail ridership.

Alternative B would result in the highest number of new transit riders, at 9,400, followed by both Alternative A and C, at 8,900.

Transit mode share for trips originating in the corridor would improve to 9 percent for each of the three Build Alternatives, when compared to the No-Build Alternative mode share of 8.3 percent. Transit mode share for trips destined to the corridor would improve to 7.2 percent to 7.3 percent (depending on Alternative) when compared to the No-Build Alternative mode share of 6.6 percent. Finally, mode share for trips originating in all of Montgomery County would improve to 8.6 percent to 8.8 percent (depending on Alternative) when compared to the No-Build Alternative mode share of 8.3 percent. See **Table 5-2** for a summary of transit mode share.

# 6.1.2 Transit Travel Times between Key Origin Destination Pairs

This MOE evaluated the transit travel time between key origin-destination pairs within the corridor as well as one pair with an origin in the corridor and the destination outside the corridor. In nearly all instances, transit travel times would be improved based on the combination of improved BRT frequencies and improved trip times.

#### 6.1.3 BRT Travel Times Compared to Local Bus Travel Times

BRT and local bus travel times were generated as outputs of the project VISSIM models and a comparison of the two was an important MOE used in comparing alternatives. The data, which was evaluated for both peak periods and both directions, shows, with few exceptions, two key patterns:

 BRT travel times would be lower, in almost all instances, than local bus travel times for each of the three BRT alternatives, meaning the transit priority treatments provided for BRT would



provide a travel time premium and make BRT a more attractive transit option. BRT travel times would also be lower than local bus travel times under the No-Build Alternative.

Local bus travel times in each of the BRT alternatives would generally increase relative to No-Build
Alternative travel times. This reflects the impact of the provision of transit priority on general
traffic operations. Because local bus operates in mixed traffic, the impacts to general traffic also
impact local bus.

While the impacts on general traffic, mentioned above, are relatively small, changes in general traffic can be magnified for local bus service.

# 6.2 Traffic and Circulation

Auto travel times were also generated as outputs of the project VISSIM models and a comparison of auto travel times to BRT travel times was an important MOE used in comparing alternatives. The data show two key patterns:

- Auto travel times would be lower, in almost all instances, than BRT travel times. This means that even with transit priority treatments, the auto would provide a time-competitive trip in comparison to BRT. These travel time differences assume "normal" corridor conditions and do not account for non-recurring congestion events such as traffic incidents. These types of non-recurring events introduce greater variability into the general purpose lanes and would not have a similar impact on Alternative B due to its physical separation.
- Auto travel times would increase under the BRT alternatives relative to the No-Build Alternative.
   This increase reflects the fact that the priority treatments installed as part of the BRT alternatives do, as noted above, have negative impacts on corridor traffic operations.

# 6.2.1 Priority Provision Impacts on Traffic Operations

A number of MOEs that were meant to measure the impact of the provision of transit priority on general traffic operations were developed and evaluated. These include Change in Number of Miles of LOS E or F by Alternative, Change in Average Person Travel Time Delay, by Alternative, and Change in Intersection Level of Service by Alternative.

The data for the first two metrics, Number of Miles of LOS E or F and Change in Person Travel Time Delay show marginal impacts to general traffic operations due to small increases in miles of LOS E or F and small increases in travel delay. The intersection LOS data also shows a relatively small number of intersections that would decline to LOS E or F when compared to the No-Build Alternative, with more intersections that would decline in the PM peak than in the AM peak.

## 6.3 Parking and Indirect Property Impacts

As part of the Build Alternatives, widening of the existing roadway along the corridor would be required and would result in impacts to existing parking. **Table 6-1** summarizes the impacts to existing surface parking by segment. With the exception of Segment 1, which would include the removal of three on-street



parking spaces to accommodate a BRT station, impacts to parking would occur on surface lots in largely commercial or business developments.

Indirect property impacts include the closure of some (but not all) property access points. All of these properties would still have at least one direct access point to MD 355. Alternative B would have four indirect property impacts and Alternative C would have ten indirect property impacts. As design progresses, efforts will be made to avoid and minimize parking impacts indirect impacts to properties along the corridor.

#### 6.4 Community Facilities and Services

Community resources such as educational facilities and libraries; health care facilities; religious facilities; and cemeteries would see minor impacts in the form of strip right-of-way takes as a result of roadway widening or BRT station construction.

Gaithersburg High School, Clarksburg High School, Montgomery College – Rockville Campus, and Montgomery College – Germantown Campus would have minor property impacts. Walter Reed National Military Medical Center, NIH, and Holy Cross Germantown Hospital would also have minor property impacts. These should not impact the function of the facilities other than minor temporary impacts incurred during construction.

Saint Mary's Church, Epworth United Methodist Church, Good Shepherd Lutheran Church, Gaithersburg Presbyterian Church, Church of the Ascension, St. Martin of Tours Catholic Church, Grace United Methodist Church, Chinese Bible Church of Maryland, Clarksburg Church, and Forest Oak Cemetery would have minor property impacts that should not impact the function of the facilities other than minor temporary impacts incurred during construction.

#### 6.4.1 Public Parks

The Build Alternatives would have modest impacts to local parks, with Alternative A impacting 0.08 acres, Alternative B impacting 1.08 acres, and Alternative C impacting 0.94 acres. Parks potentially affected



include Boher Park in Gaithersburg and Seneca Creek State Park. Effects on each of the parks would involve small sliver takes along MD 355 and not have an adverse effect on existing or planned park amenities or park use characteristics. Additional planning, design considerations, and formal coordination with parks owners and management agencies would be completed during future design phases if impacts to parks cannot be avoided.
