At an upcoming virtual public hearing, residents will have an opportunity to present oral and/or written comments concerning the abandonment of a portion of a 15-foot wide public alley covering approximately 301 S.F. behind a property located at 4803 Bayard Boulevard, Bethesda, MD 20816. The petition seeks to abandon the Public Alley on the basis that there is no current or anticipated future public use of the alley.
