Re: Abandonment Case AB 785 (Portion of Northfield Road) Notice of Executive Order Authorizing a Public Hearing for AB 785

To Whom It May Concern,

Please be advised that the Property Acquisition Section of the Montgomery County Department of Transportation has received a petition to abandon a portion of Northfield Road right-of-way in Bethesda, Maryland. The abandonment is being requested by the owners of properties located adjacent to the abandonment area, 8401 Moorland Road and 5423 Northfield Road. Pursuant to Montgomery County Code section 49-62(e), a virtual Public Hearing date has been scheduled to address the petitioned abandonment. The County Executive or his Designee shall conduct a Public Hearing on:

Monday, July 24, 2023 at 1:00 PM, via the internet-based platform known as Zoom.

The Department will place a sign on the property to notify the community of the Public Hearing date and time.
