Please be advised that the Property Acquisition Section of the Montgomery County Department of Transportation (MDOT), pursuant to Section 49-62 of the Montgomery County Code (2014) as amended, the County Executive or his Designee shall conduct a virtual Public Hearing to consider an application from 5500 Westbard Avenue Block Civic Association (the "Applicant"), for the permanent closure of a public right of way at the [northwestern terminus of Westbard Avenue at River Road](#) in the Westbard area of Bethesda.

The Applicant, through their petition, request permanent closure of the public right of way, pursuant to the [2016 Westbard Sector Plan](#), from all vehicular traffic, including emergency vehicles, at the intersection. The petition also requests that a temporary closure remain in place until a permanent closure can be installed. Attached, please find the following information concerning the application:
