Declaration of No Further Need Recitals

WHEREAS, Montgomery County, Maryland (the "County") is the owner of the land and improvements located at 1920 Seminary Road, Silver Spring MD and 13504 New Hampshire Avenue, Silver Spring, Maryland; and

WHEREAS, the property is located within the Silver Spring Parking Lot District ("PLD"), and upon the property, the Montgomery County Department of Transportation ("MCDOT") Division of Parking Management operates and maintains a public parking lot known as Lot #12

WHEREAS, the property is located within Silver Spring, Maryland and upon the property, the Montgomery County Department of Transportation ("MCDOT") Division of Parking Management operates and maintains a public parking lot known as the Colesville Commuter Lot; and

WHEREAS, Montgomery County will enter into a 10-year lease arrangement with Francis Energy, with the option to renew for an additional five (5) years. Lease Agreement with Francis Energy to improve twelve (12) existing parking spaces (1,950 square feet) in Lot 12 and fourteen (14) spaces (2,150 square feet) in the Colesville Commuter lot with DC fast charge Electric Vehicle stations; and

WHEREAS, the lease may not be consummated without going through the property disposition process as required by Section 1llB-45 of the County Code and applicable Code of Montgomery County Regulations; and

WHEREAS, Executive Branch departments performed a Preliminary Reuse Review and a Reuse Analysis for Lot 12 and for the Colesville Commuter Lot as required by law, and the Executive determined that the spaces are no longer needed for public use during the proposed lease and is appropriate for disposition through a lease to Francis Energy for the duration of the proposed term; and

WHEREAS, the Executive has sent to the County Council the material terms of the proposed disposition of the two lots to Francis Energy for the proposed term at fair market value; and
