<u>Snowden Farm Parkway:</u> A closed section modified arterial roadway (MCDOT Std. 213.04) with a right of way 80 feet wide beginning at Station 7+19.48 and continuing in an easterly direction ending at Station 25+35.14 for a distance of 1815.66 feet. Paving width varies from 38 feet to 28 feet in width, concrete sidewalk on the north side only, five (5) feet in width and within the dedicated right of way, asphaltic concrete shared use path on the south side only, eight (8') feet in width and within the dedicated right of way, eight inch (8") graded aggregate base, five inch (5") asphaltic concrete base course, 1.5" asphaltic concrete intermediate course and a 1.5" inch asphaltic concrete surface course.

<u>Clarksburg Square Road:</u> A closed section tertiary roadway (MCDOT Std. 211.01) with a right of way 60 feet in width beginning at Station 8+54.00 and continuing in a northeasterly direction ending at Station 17+17.00 for a total distance of 863 feet. Paving width varies from 24 feet to 38 feet, streetscape brick paver sidewalks, five (5') in width, on both sides and within the dedicated right of way, intersecting Public House Drive at Station 10+20.00. Concrete curb and gutters, three inch (3") asphaltic concrete base course, 1.5-inch asphaltic concrete intermediate course, and a 1.5-inch asphaltic concrete surface course.
