Parkdale Court: A closed section secondary residential roadway (MCDOT Std. 2002.01) with a right of way 60 feet in width beginning 285 feet west of the intersection with Frederick Road (Maryland Route 355). Beginning at Station 0+00 at the intersection of West Old Baltimore Road and continuing in a southerly direction terminating in a cul-de-sac at station 7+43.97. Paving width 28 feet, concrete sidewalks five (5') feet in width on both sides and within the dedicated right of way. Curb and gutter, paving consisting of a 3-inch asphaltic concrete base course, a 1.5-inch asphaltic concrete intermediate course and a 1.5-inch asphaltic concrete surface course for a total distance of 743.97 feet.

Red Oak Ridge Place: A closed section secondary residential roadway (MCDOT Std. 2002.01) with a right of way 60 feet in width beginning at the intersection of West Old Baltimore Road (Station 0+06) at Station 0+00 and continuing in a northerly direction terminating in a cul-de-sac at station 8+97.85 intersecting with a private alley at station 1+75.00 and again at station 4+65.00. Paving width 28 feet, concrete sidewalks five (5') feet in width on both sides and within the dedicated right of way. Curb and gutter, paving consisting of a 3-inch asphaltic concrete base course, a 1.5-inch asphaltic concrete intermediate course and a 1.5-inch asphaltic concrete surface course for a total distance of 897.85 feet.

Paving width 20 feet, concrete sidewalks five (5') feet in width on both sides and within the dedicated right of way. Curb and gutter, paving consisting of a 3-inch asphaltic concrete base course, a 1.5-inch asphaltic concrete intermediate course and a 1.5-inch asphaltic concrete surface course for a total distance of 424.32 feet.
