1a	<u>INSTALL:</u> No Parking Any Time	<u>In Gaithersburg:</u> on the east, north and west sides of Honeylocust Circle from the eastern intersection with Flower Hill Way to the western intersection with Flower Hill Way except in designated parking spaces.
2a	<u>INSTALL:</u> No Parking Any Time	<u>In Gaithersburg:</u> on the east side of Honeylocust Circle from the western intersection with Flower Hill Way to 325 feet north of the western intersection with Flower Hill Way except in designated parking spaces.
3a	<u>INSTALL:</u> No Parking Any Time	<u>In Gaithersburg:</u> on the east side of Honeylocust Circle from 365 feet north of the western intersection with Flower Hill Way to 530 feet north of the western intersection with Flower Hill Way except in designated parking spaces.
4a	<u>INSTALL:</u> No Parking Any Time	<u>In Gaithersburg:</u> on the west side of Honeylocust Circle from 455 feet north of the eastern intersection with Flower Hill Way to 270 feet north of the eastern intersection with Flower Hill Way except in designated parking spaces.
5a	<u>INSTALL:</u> No Parking Any Time	<u>In Gaithersburg:</u> on the west side of Honeylocust Circle from 130 feet north the eastern intersection with Flower Hill Way to the eastern intersection with Flower Hill Way.
