Call To Order

Welcome and Introductions

Kimberley McBride welcomed attendees, and everyone introduced themselves.

Meeting Minutes Agenda Items

1. Community Health Improvement Plan (CHIP) Discussion and Update
 - a. The CHIP is being finalized and will be available for HMSC review soon. HMSC voting members will receive 3 weeks to review the CHIP draft and provide feedback via an online SurveyMonkey form.
 - i. Suggestion from Dr. Nguyen Nguyen: Have HMSC members meet to discuss CHIP before voting via online survey after initial review.
 - ii. Question from Henry Montes: How will the CHIP be distributed and understood by community members and nonprofits? Dr. Davis noted that a copy would be made available in “plain English”. Elizabeth Beck noted there will be an online dashboard where progress can be tracked.
 - b. DHHS and the Montgomery County Hospital Collaborative (MCHC) are hosting a CHIP Roundtable event on Monday, January 12, at the Silver Spring Civic Center. Invites have been sent via email. The roundtable event will feature progress made on the CHIP and its process, an overview of the health priority areas, collaborative efforts aimed at improving health outcomes for the county, and an opportunity to hear from participants on the following:
 - i. What stood out to them about the CHIP.
 - ii. How the CHIP priorities connect with their work, partnerships, coalitions, or other initiatives.
 - iii. How the CHIP Health Priority Action Teams could best support them, either through data sharing, networking, capacity building, or policy alignment.
 - iv. An opportunity to share any resources or support they can contribute to the CHIP process.
 - c. We are continuing to build collective impact and share updates regarding CHIP progress. The CHIP is a living document and will be continuously monitored and evaluated.
2. Presentation: Adverse Pregnancy Metric
 - a. Dr. Chunfu Liu presented on the Adverse Pregnancy Metric, which was created as a metric to allow the Montgomery County DHHS Maternal Child Health program participants to understand their risk of preterm birth and having a baby with low birth weight.
