### ESSAY CONTEST BASICS

- You do not need a library card to enter.
- Completed entries are due between **Monday November 1, 2021 and Wednesday December 15, 2021.**
- Electronic submissions only. All entries must include both essay and entry form at time of submission, and must be submitted to [MCPL.MoComCon@montgomerycountymd.gov](mailto:MCPL.MoComCon@montgomerycountymd.gov) by deadline.
- The top three Essay Contest entries in each age group will be published for viewing online via the MCPL website. Essay Contest is for ages 8–14. Author's names will not be released.
- **Deadline** for entries:  
**5 PM, Wednesday, December 15, 2021.**

### ESSAY CONTEST GUIDELINES:

- Write an essay, 300–500 words, about the following prompt: **What game changed your life?**
- Tell us what the game is, how and when you discovered it, and how it has made an impact on you and your life.
- Essays must be suitable for a family environment. No explicit content, images, words, or weapons.
- Contestants must adhere to all MCPL Guidelines Governing the Use of Public Libraries and Guidelines for Behavior.
- Essay entries must be your own original work.
- Essay Contest is for ages 8–14.
- Limit: one Essay entry per person.
- Before the deadline of **5 PM, Saturday, January 8, 2022**, submit:
  - One Word or PDF file of the Essay
  - AND**
  - One completed electronic entry form to go with it.

### ESSAY CONTEST PRIZES:

- Entries in the Essay contest will be judged on creativity, style, and appeal.
- Prizes will be awarded to 1st, 2nd, and 3rd place winners.
- Essay contest finalists and winners will be notified by email or phone prior to MoComCon.
- Essay Prizes will be available for pickup at the contestant's selected MCPL library after January 18, 2022
- All judges' decisions are final.
