100 - CALL TO ORDER

103 – FIRE CHIEF'S REPORT

No Official Report, but Chief Smedley introduced himself to the group; this is his first meeting. He speaks about his leadership philosophy and 100-day plan; today, we signed Bill 7-24 into action. The updated EMS Billing Draft will go to Council in September, two main things we do soft billing, will take the word Transport out of the legislation, which allows us to take advantage of resources when we administer care in place, we will also be able to ask who your insurance is through, for example if you have Kaiser we could take you to a Kaiser facility.

Today we went Live with Whole Blood-

Asst Chief Kaufman- Whole Blood is relatively new only 8-10 years old in the country. State Police medivac troopers were the first to carry whole blood. They've been doing it for a few years; Howard County Fire and Rescue started carrying it last year, and today, we became the 3rd agency. So we can give [whole?] blood when someone is in hemorrhagic shock. The supervisor can administer [whole?] blood and stay with the patient until they get to the hospital. MCFRS started the program today.

Fire Chief -Working through the 100-day plan, preparing for the FY 26 Budget process, adamantly documenting our needs, and requesting what we need.

Chairperson Powell-Will we have a chance to comment on the Ambulance Billing?

Fire Chief- I will review the purpose of the FESC and will follow the guidelines set forth.

Chairperson Powell- What do the Commissioners think?

Member Miller—This bill originates under the County Council. The County Council is not under any obligation to request comments from the Commission, but it is a public bill, so we can comment as the public, but we are not required to as a commission. It's not a big deal to get it and comment on it.

Chairperson Powell- Any other comments on the Bill or for Asst Chief Kaufman or the Fire Chief Smedley

Commissioner Callen – as discussed and per agreement with former Chief Goldstein, members of the FESC would appreciate the opportunity to review the draft MCFRS budget before it is finalized.

Member Dempsey—Chief, your efforts in getting out in the Field are very well reciprocated. This is a great step toward getting out and getting known.

Chairperson Powell- Any other Comments?

Commissioner Callen - Need for transparency, need for sharing information, the possibility of developing a website would be an excellent tool that we could use to archive information and would be easy for the public to view... maybe we could get a staff person in the county or an intern to help make a website? Wants to put it out there to see what the other commissioners think... It should be very easily accessible; she doesn't want the public to have to go deep into the county website to find out about the FESC but instead it should be easy for the public to access documents to see everything.

Fire Chief- Is there a standard approach for commissions? If there is, we should follow that. Is there a guideline on how to display information to the community? We would like to make sure that we are in compliance.

Commissioner Callen -She has reached out to Beth Gochrach for guidance.
