#### V. Presentations - 7:20 PM -

1. Wheaton Placemaking Initiative - Jessica McVary (Midcounty Planning Supervisor) and Sophie Kotzker (Midcounty Planner II) from Montgomery Planning .

This project is an opportunity to help Wheaton live up to all it can be. Presentation link can be found on this website.

- Wheaton Downtown study was completed in 2023 with near- mid- and long-term strategies. The Wheaton Triangle was the focus. Connectivity, public amenities, and art are priorities. This set of placemaking initiatives will be installed for 3 - 6 months in spring of 2025 (through fall events).

This is one small piece of all of the work going on to improve Wheaton. It will include:

- Pedestrian pathway through Core.
- Activated public space for relaxing, eating, etc.
- Brochure with info re: getting around the Core.

The project has recently started with community feedback; expecting to evolve. Consultants have been activated.

Currently, the Core lacks a central focal point, connectivity, and gateways.

Community engagement events are planned for the next few months.

#### Questions/Comments:

Who was at the consultants meeting? Property owners, Jim, SHA. We want to hear from anyone who interacts with this space.

Will the Triangle parking lot be used for placemaking activities (not parking)? Yes, it is central, so we will probably try using it for outdoor seating, etc. There is a large parking lot right there under the P&P building.

The Streetery has not moved forward in terms of pedestrian access/throughways. I hope this project will prioritize pedestrian access.

Crystal - this winter, the crossing/traffic signal on Georgia Georgia at Price should start construction. Hopeful that it should be finished in the spring/summer.

Why is the focal point the Triangle Parking Lot, not Marion Fryer Plaza? Is there a budget to include artists or other community participants? Partnering with artists is possible. Stay tuned. There is a budget; we are working with a consultant, which might get artists involved. We are happy to get additional input.

This is an opportunity to have a situation like Ellsworth in Silver Spring.

Reminder: Ellsworth is owned by private developer. We are dealing with government ownership and scattered private ownership.

But remember that the government DOES have the capacity to be creative, so ASK! For instance, Price Ave could be closed on weekends, etc.

We are working toward proof of concept by implementing placemaking ideas on a short term basis so that they can be experienced, evaluated, and potentially become long term. Consultant is Yard and Company out of Cincinnati, and are working with local groups, too.
