3. Unfinished Business.

The administrative Director preluded the ad hoc presentation with a briefing of the board's Special Legal Counsel request to make use of the Maryland Public Information Act (MPIA), precautions the board should exercise with specifics of any complaints, and confidentiality agreements are under the Code of Maryland Regulations (COMAR) therefore is prudent to await direction from Special Legal Counsel.

AHG discussed their purpose in reviewing trends analysis. Challenges were noted in identifying trends, data collection, recording data, accuracy concerns, demographics, sorting complaints, and categorizing complaints.

Upon review of the ACC's written opinions, the findings and detailed reasoning were extremely helpful, but additional challenges included the absence of information about the officers (ethnicity and rank). Possible future inquiries to the Chiefs may include improving policing for unfounded complaints.

The IAPro Case Management system can model the demographics request, although the legal requirements do not require information to be disclosed outside of the ACC request. The LEA has reported reference demographics, but they do not relate to complaints.

PAB Staff presented the Policy Viewer tracker, which includes policy sources and allows members to categorize broader rules for public utilization. It was noted that the LEA policies have some similarities, yet there are differences in both the titles and content. The tracker will allow members to compare data and see how the rule could affect officer charging.
