Jewish parents felt the posts were hurtful and about their children's safety at the school The teacher will be suspended until MCPS finishes an investigation. chool student made an antisemitic comment in class. The teacher reported the comment to school administrators. slur was found written on a desk in an elementary school. The subject stated he didn't mean to do it, he knew he ng, and he knew it was inappropriate and stated that he had heard similar racial slurs used fellow classmates Black themselves. The school handle the matter administratively.

e school student (subject) drew a picture of a swastika which was displayed on the overhead projector. The Asst. I questioned the subject and stated that he believed the subject did not know what the symbol meant and the stated they drew the picture because they were bored and did not know the symbol had meaning. The school will he matter administratively.

m and her caretaker reported that the caretaker's vehicle and various doors of the victim's home had been ed. The victim has a sign in her yard showing support for Israel and believes this is the reason she was targeted. ere no other reports of anything similar occurring in the neighborhood.

panic males (victims) and a child were on a bus when a verbal altercation ensued between the victims and patron (subject), with the subject making a derogatory comment about Latinos. The altercation became physical n parties throwing punches. The two victims appeared intoxicated on the bus and the child was observed a beer bottle at the subject during the fight. Video will be reviewed for further investigation.

nentary school students were on a bus returning from a field trip when one called the other a derogarory racial e two students have a history of pinching and hitting each other and calling each other a derogatory names. of the students reported any of the events to a staff member or a parent.

of middle school students attempted to strike another student (victim) calling him a homophobis term. The victim prosexual but associates with other students who may identify as LGBTQ. No physical contact was made during cation. School administration interviewed all parties but was unable to verify if bias language was used. The *v*ill handle the consequences.

m observed vandalism to a wooden fence on his property which the victim felt was meant to represent his family. m felt this was a hate crime due to his religious beliefs.

chool teacher was monitoring student computer usage using a software program when she clicked on one (subject #1), who was sharing a computer with another student (subject #2), and found a derogatory racial term n typed in the search bar. When interviewed, Subject #1 said that Subject #2 typed the words, but Subject #2 to be subjects were transferred out of the class and Subject #2 was given out-of-school suspension.
