Summary

A verbal altercation occurred between a bicyclist and a driver, in which the driver made a derogatory and antisemitic remark.

Two elementary school students (subjects) tried to get another student to teach them how to say racist remarks in a foreign language. Two students overheard this conversation and reported it to their teacher. The school will conduct follow-up.

Two elementary school students (subjects) had referenced another student's sexuality on a page in a notebook. That student never saw what was written in the notebook. The school will conduct follow-up.

Two swastikas were found drawn on a middle school classroom desk. The images were easily removed, no permanent damage.

A middle school subject called the victim a racial slur. The subject admitted saying it and that he didn't know what the word meant and apologized to the victim. The principal facilitated a discussion between both students to educate them on the meaning and history of the word. A homeless man (victim) was threatened by an unknown subject. The subject later returned and threatened the victim again, using a derogatory racial slur. The victim walked over to the security office at a shopping mall where police were contacted on his behalf.

An elementary school student (subject) made a derogatory homophobic comment to the victim. The subject has made similar comments in the past. The school will issue consequences or discipline.

An unknown subject utilized "sticky notes" to make the shape of a swastika in the boys' restroom of a middle school.

A complaint was received at a middle school concerning anti-transgender comments.

The victim was called a derogatory racial slur when the subject attempted to steal her purse. The subject was later arrested, along with two other individuals.

A complainant observed graffiti on a walking path with a racial slur spray painted in black paint on the walking path.

An elementary school student (victim), who is Jewish, found a piece of paper with a swastika drawn on it in his backpack. The student that sits next to the victim has drawn swastikas on the victim's belongings in the past. The students will no longer sit next to each other in class. A middle school teacher found a small swastika drawn in pencil on a desk in a classroom.

An elementary school student (subject) directed his attention toward another student (victim) and made a derogatory racial comment. The school will be conducting follow up.

An elementary school student (subject) directed his attention toward two other students and made a derogatory racial comment. The school will conduct follow up.

An elementary school student (subject) directed his attention toward another student (victim) and made a derogatory racial comment. The school will conduct follow-up.

A swastika and other words were etched into the wooden seat of the metal stool in a high school classroom. The etchings also appeared to be older. There is no

timeframe for when the vandalism occurred.

An elementary school teacher found a"swastika" engraved in pencil on a jenga building block. Unknown subject.

A drawing of a swastika was found in the boys' bathroom of a middle school. There are no cameras or witnesses to this incident.

An elementary school student (subject) directed her attention toward another student (victim) and made a derogatory racial comment. The school will conduct follow-up.

A salesman (victim) making door-to-door calls was approached by the subject who was yelling racial slurs and pepper sprayed the victim. A witness corroborated the victim's account of events.

A drawing of a swastika was found on a desk in a middle school. The drawing was in pencil and was erased by the assistant principal.

Two female Asian victims were waiting to cross an intersection when an unknown male subject started yelling racial slurs at them from his vehicle. When the light turned, the subject made a uturn at the light and drove toward the victims, almost hitting them, and still yelling at them. Two juvenile subjects walked over to the church's sign, which displays both a Black Lives Matter flag and a pride flag. One juvenile took down the pride flag and broke it in half before fleeing. The incident was captured on security footage. The incident appeared to involve students from a high school.

A swastika was found drawn inside a drawer of a middle school classroom. The school has reported finding swastika symbols around the school for the past three to four weeks, and other police reports have been made.

A swastika was drawn on a high school table. School staff removed the image.

A swastika was drawn in pencil on the wall of a boys bathroom of a middle school.

A swastika appeared to have been etched into a classroom table. A close examination of the table with a naked eye showed nothing. The school custodial worker sanded the table to ensure all unseen images were removed.

A swastika was drawn in pencil, on the gym floor of a middle school.

A swastika was drawn on a table at a high school.

Following an investigation of bullying, information revealed one student called another student a racial slur. There was a recording of the subject using the slur and he admitted to saying it when questioned. The school will issue consequences and the subject will be withdrawing from school.

A middle school student (victim) was called an ethnically derogatory term by two other students. Each child involved was re-educated on bias/racial comments and the school will handle the matter administratively.

An anonymous complaint was made at a middle school, that a student was playing a game in which a homophobic statement was made. The complainant was upset and reported the incident.

A victim had 4-5 eggs thrown at her house. Home security video showed two subjects. No other houses appeared to have been vandalized. The victim believes this is a racially motivated hate crime.

Tennis courts at a high school were vandalized with what appeared to be a person's name. The school confirmed there was no student by that name. This was thought to be a hate/bias inscription directed towards the tennis coach who is part of the LGBTQ community. The name was removed without damage to the courts.

A middle school student (subject) called another student (victim) derogatory terms relating to the victim's middle eastern descent. Witnesses overheard the comments.

A swastika was found drawn on a high school desk.

A swastika was written on the door of the boys' bathroom in a middle school.

A middle school student (subject) called two other students (victims) a derogatory ethnic term. Other students overheard this comment and brought it to he attention of the teacher. The school will handle the incident administratively.

A middle school subject approached two victims and made derogatory comments regarding the victims' religion. The parents of all students involved were contacted and advised of the incident. School administration will be handling the disciplinary consequences.

An unknown male subject called a hospital ER asking questions about a prominent politial figure and made references to upcoming protests. The complainant said the subject made "a lot of anti-Semitic comments," but did not elaborate further.

A middle school student (victim) had been bullied for several months by another student (subject) and in this incident was physically assaulted by the subject. When asked why the subject did this, he made an antisemitic comment about the victim. The school will handle the incident administratively.

A high school student (subject) had made numerous racist and homophobic comments in class. The school will work with the student on making better choices.

A swastika had been drawn in black pen on one of the middle school classroom desks.

A swastika was drawn on a rear, exterior door of a middle school.

A middle school teacher observed that a student (subject) had drawn swastikas and cartoon characters on a sheet of paper along with an antisemitic comment. The subject stated that he watches a popular television show and was copying a character that makes insulting comments. The subject does not have a history of these types of incidents and was not targeting anyone. The school will handle the incident.

A middle school student (subject) created a google doc with a racial slur and derogatory images. When asked why he did this the subject stated that he was dared to do it by one of his friends. The document had also been shared with another student in that class. The school will handle this incident administratively.

The subject had made derogatory social media comments because he was previously involved in a traumatic incident where he was racially targeted. The subject admits to having mental health issues and not taking his medication regularly. The subject and his family were given the number of the crisis center for additional resources.
