4/28/2025	6D	Verbal Intimidation/Simple Assault	Ancestry		Anti-Hispanic		Individual(s)	Following a collision, the complainant stated that the subject told her she did not "belong here," and should "go back to [her] country." The subject admitted to making the comments, and said he apologized, but the complainant was still very upset.
4/28/2025	1D	Weapon-Threat to Shoot	Race		Anti-Black		Individual(s)	A middle school student made threatening and racist statements on social media against the school and a member of the school staff. The subject's parent confirmed there were no weapons in the residence. The school will handle the incident administratively.
4/28/2025	2D	Vandalism	Race		Anti-Black		School/College	Four girls' bathrooms in a middle school were vandalized with a racial slur. The school will handle the incident administratively.
4/26/2025	GCPD	Vandalism	Race		Anti-Black		Business/Financial Institution	A pallet of merchandise had a racial slur written in red spray paint on the plastic wrapping.
4/23/2025	6D	Other	Religion		Anti-Jewish		School/College	A high school student drew a swastika on a classroom whiteboard. Other students saw the drawing and told the subject the image was offensive and that he should erase it, which he did. The next day, in the same classroom, the subject drew a symbol that resembled a swastika but had wavy/squiggly lines on the extended arms of drawing. The subject told the students it was a fan, not a swatika. The students reported both incidents to school staff. The school will handle the consequenses.
4/22/2025	4D	Verbal Intimidation/Simple Assault	Race		Anti-Black		Individual(s)	The victim and his friends were walking home from middle school when a vehicle approached them, and an unknown passenger (subject) rolled down the window and yelled a racial slur at the victim. The victim yelled back at the subject. The subject vehicle then turned around, the subject yelled at the victim again, then left the area.
4/20/2025	RCPD	Assault (simple)	Race		Anti-Black		Individual(s)	An altercation occurred between roommates, where one tried to punch the other. When the victim left the residence to call police, the subject followed and kicked the victim and called him racial slurs. The victim advised that the subject had threatened him in the past and that he was in fear for his safety. The victim was given information on obtaining a peace order or press charges.

A physical altercation ensued, where the subject allegedly threatened the victims with a knife. The subject was arrested and a folding knife was found in his possession. The subject was charged with the following:  Two counts of CR 3-202 **ASSAULT-FIRST DEGREE** *1_1410*  Two counts of CR 3-203 **ASSAULT-SEC DEGREE** *1_1415*

This building has limited badge access and this room is hardly used. The complainant provided a list of those who have badged into this room for 2025.

The unknown subject referenced the immigration status of both the victim and his wife. The victim reported the subject's account. The victim feels the subject's posts were racially and politically motivated.

The subject approached one of the victim's children and referenced the parents' immigration status. The subject brandished a knife after the victim continued to engage him.

When the victim honked the horn, the subject got out of his car, armed with a knife, and called the victim a racial slur multiple times, then hit the window with the knife twice. The subject again used a racial slur toward the victim and stabbed the rear tire with the knife, causing the tire to flatten. The subject got back in his vehicle and fled the area.

On multiple occasions, the subject would yell and scream at the victim. In today's incident, the subject yelled at the victim that he hated her and called her a racial slur. The victim stated that the subject yelled this same statement multiple times toward her.

The victim blocked the subject's account. The teacher then reported it to the school.
