In accordance with §11B-69 of the Montgomery County Code, I am pleased to attach the annual activity report for the Local Small Business Reserve Program for FY24.

The County spent \$130.5 million with local small businesses in FY24. This amount includes \$9.7 million (32.2%) through LSBRP-advertised solicitations and awards, and \$120.8 million that was exempted from LSBRP but still awarded to local small businesses.

Local Small Business Reserve Program (LSBRP)

Message from the Director



The Montgomery County Local Small Business Reserve Program (LSBRP) continues to be a valuable procurement vehicle for Montgomery County-based small businesses, providing them with opportunities to compete for the County's contracting dollars. In FY24, the Office of Procurement collaborated with numerous business organizations and local small vendors, achieving a record high of 32.2% of eligible spending towards Montgomery County-based small businesses.

This year, the Office of Procurement introduced the "Pathways to Partnership" program, offering targeted assistance through a variety of

services. These include networking opportunities with key stakeholders in public sector contracting, enabling participants to focus on capacity-building, access to resources, and long-term business development. The program aims to level the playing field, increase market access, and promote the inclusion of diverse vendors in public procurements. Ultimately, the goal is to empower local, small, and minority-owned vendors to scale their businesses, expand their roles in the county's contracting landscape, and increase diversity in the procurement process.

We look forward to continuing to strengthen connections between the business community and County departments to support the growth of County contracting activity with local small businesses.

Executive Summary

FY24 was a successful year for the local business programs administered by Montgomery County Office of Procurement. The three local business programs are: the Local Small Business Reserve Program (LSBRP), the Local Business Preference Program (LBPP), and the Local Business Subcontractor Program (LBSP). This report focuses on the LSBRP.

The County spent \$130.5 million with local small businesses in FY24. This amount includes \$9.7 million (32.2%) through LSBRP-advertised solicitations and awards, and \$120.8 million that was exempted from LSBRP but still awarded to local small businesses.

In addition, total LSBRP eligible Direct Purchase Orders (DPOs) was \$3,593,114¹; 38% of which, or \$1,380,045, was spent towards Montgomery County-based businesses.

Background

The accomplishments outlined in this report result from several initiatives to stimulate economic growth through local contracting. In FY2009, a partial governmental reorganization was implemented, creating the Department of General Services and the Office of Business Relations and Compliance. The County Executive and County Council also enacted new legislation and Executive Regulations to expand the County's ability to contract with local businesses:

- 1. Local Small Business Reserve Bill #3-09 (April 30, 2009) -- Established the Director as the evaluator of a business's capacity to contractually perform.
- 2. Expedited Bill #23-15 (January 1, 2016) Amended LSBRP eligibility criteria for small businesses in the service sector.
- 3. Local Small Business Program Amendment Bill #39-19 (March 2, 2020) Increased the LSBRP goal from 20% to 25% of eligible procurement actions.

Marketing and Outreach

Throughout the year, the Office of Procurement organized targeted outreach events that attracted vendors from all disciplines and sectors of the business community. The objective of these events was to invite local, small and minority vendors to participate in the County's procurement process. Government agencies and business organizations that have an interest in the County's socioeconomic business programs were among the key participants. These well-attended and popular events provided opportunities to local and minority vendors to better understand County contracting procedures and opportunities, as well as County policies related to local, small and minority vendors.

In FY24, the Office of Procurement hosted a total of 40 events, including 12 monthly Online Open Houses and two signature in-person annual events that were held in the Fall and Spring. (* Events hosted or co-hosted by the Office of Procurement)

Local Small Business Reserve Program – DPO spending

Council Bill 39-19, LSBRP Amendments, was enacted on June 1, 2020. Among other general amendments, the Bill amended the LSBRP as follows:

- (1) Subject to Method 2 regulations, a using department's procurement procedures must award a minimum of 25 percent of the using department's combined dollar value of contracts issued for goods, services, or construction, including direct purchases, to local small businesses.
- (2) A using department must have a goal to award at least 50 percent of the combined dollar value of its direct purchases to local small businesses.

Direct Purchase is an informal procurement of goods, services, or construction that is accomplished under the direct authority of the using department head and not by the Procurement Director. Competition should be preserved with this method to the extent practical. Contracting with Local, Small, and MFD firms is encouraged. The current DPO threshold is \$10,000.

In FY24, total LSBRP eligible DPOs were \$3,593,113.86⁵, of which \$1,380,045.37 (38%), was spent towards Montgomery County-based businesses.
