Message from the Director



The Montgomery County Local Small Business Reserve Program (LSBRP) continues to be a valuable procurement vehicle for Montgomery County-based small businesses, providing them with opportunities to compete for the County's contracting dollars. In FY25, the Office of Procurement collaborated with numerous business organizations and local small vendors, achieving \$133 million, and a record high of 33.7% of eligible spending towards Montgomery County-based small businesses. In FY25, under the LSBRP, the Office of Procurement launched a Veteran-Owned Business Preference Program (VBPP). Certified, county-based veteran-owned businesses will receive additional evaluation points worth 5% of the total points available for proposals submitted under the LSBRP.

Montgomery County is proud to be home to so many local small businesses who contribute to the well-being of our community and the region; many of them are also federal contractors impacted by recent changes in federal grants and contracting policies. In March 2025, the Office of Procurement hosted a "Montgomery County is OPEN for Business" event, helping county-based federal contractors to explore business opportunities with local government. We recognize that these businesses are facing real challenges, and we want to be part of the solution. By helping them learn how to do business with the County, we will provide opportunities for them to diversify their revenue streams and continue providing good jobs and valuable services in the County.

We look forward to continuing to strengthen connections between the business community and County departments to support the growth of County contracting activity with local small businesses.

Executive Summary

FY25 was a successful year for the local business programs administered by the Montgomery County Office of Procurement. The three local business programs are the Local Small Business Reserve Program (LSBRP), the Local Business Preference Program (LBPP), and the Local Business Subcontractor Program (LBSP). This report focuses on the LSBRP.

The County spent \$133 million with local small businesses in FY25. This amount includes \$22.97 million (33.7%) through LSBRP-advertised solicitations and awards, and \$109.96 million that was exempted from LSBRP but still awarded to local small businesses.

In addition, total LSBRP eligible Direct Purchase Orders (DPOs) was \$2,288,021¹; 28% of which, or \$636,936, was spent towards Montgomery County-based businesses.

Background

The accomplishments outlined in this report result from several initiatives to stimulate economic growth through local contracting. In FY2009, a partial governmental reorganization was implemented, creating the Department of General Services and the Office of Business Relations and Compliance (within in the Office of Procurement). The County Executive and County Council also enacted new legislation and Executive Regulations to expand the County's ability to contract with local businesses:

- 1. Expedited Bill #23-15 (January 1, 2016) Amended LSBRP eligibility criteria for small businesses in the service sector.
- 2. Local Small Business Program Amendment Bill #39-19 (March 2, 2020) Increased the LSBRP goal from 20% to 25% of eligible procurement actions.

Marketing and Outreach

Throughout the year, the Office of Procurement organized targeted outreach events that attracted vendors from all disciplines and sectors of the business community. The objective of these events was to invite local, small and minority vendors to participate in the County's procurement process. Government agencies and business organizations that have an interest in the County's socioeconomic business programs were among the key participants. These popular events were well attended and provided opportunities to local and minority vendors to better understand County contracting procedures and opportunities, as well as County policies related to local, small and minority vendors.

Local Small Business Reserve Program – DPO spending

Council Bill 39-19, LSBRP Amendments, was enacted on June 1, 2020. Among other general amendments, the Bill amended the LSBRP as follows:

- (1) Subject to Method 2 regulations, a using department's procurement procedures must award a minimum of 25 percent of the using department's combined dollar value of contracts issued for goods, services, or construction, including direct purchases, to local small businesses.
- (2) A using department must have a goal to award at least 50 percent of the combined dollar value of its direct purchases to local small businesses.

Direct Purchase is an informal procurement of goods, services, or construction that is accomplished under the direct authority of the using department head and not by the Procurement Director. Competition should be preserved with this method to the extent practical. Contracting with Local, Small, and MFD firms is encouraged. The current DPO threshold is \$10,000.

In FY25, total LSBRP eligible DPOs were \$2,288,021.53⁴; Of these eligible DPOs, 28% or \$636,936.15, was spent towards Montgomery County based businesses.
